Shall the existing Delaware County sales tax of one half of one percent (1/2 of 1%) currently levied upon the gross receipts or gross proceeds derived from all taxable sales within the County be extended, with no increase in sales tax rate, for an indefinite period of time or until repealed by the voters of Delaware County as required by law, the proceeds of said extended but not increased sales tax to be utilized for county transportation infrastructure purposes, including but not limited to road and bridge construction, operation, repair, and maintenance, authorizing the pledging of the sales tax revenues for the payment of debt service, if applicable, be approved?
