Commissioner Smith stated that these bonds were issued on May 22, 2013 for the purpose of providing funds to Delaware County to pay a judgment levied against the County. The County Treasurer has furnished the Commissioners with a report and projections showing a projected \$850,000.00 of excess sales tax proceeds to be available on September 1, 2014 to pay off bonds.
