Commissioner Duncan said the road would be receiving a low water crossing road repair and would be repaired due to the school requesting this as said road is part of a bus route. Richard Huston, Tiff City Fire Department, addressed the Board regarding a warrant that had went through a previous meeting for the purchase or real property for the Fire Department. The original warrant was made to Liberty Bank; however it needed to be made to Grand River Abstract. Mr. Huston wanted to clarify this in case the Board had any questions, which they did not. Commissioner Duncan wanted to let the Board know that renewal of CDL licensing for his employees has not correctly categorized one of his employees and wanted to forewarn the Board and noted that he will be having all of his employees licenses reviewed to make sure they were all up to code.
