- 10) V-07989-Lawful exemption deductions have not been taken into account.

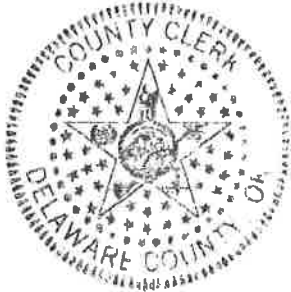
Roll call: Don Youngblood-yes, Larena Ellis-Cook-yes. Motion carried.
