- 11) V-08002-Stacy, Anita-Error in transcribing from County Assessor's survey record to assessment rolls.

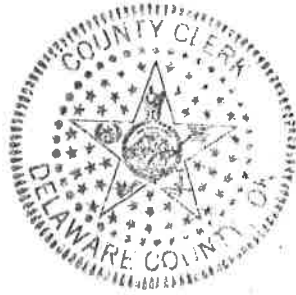
Roll call: Don Youngblood-yes, Wayne Tudor-yes. Motion carried.
