The projected figures for Ad Valorem Revenues for FY 2013 are \$71,012.82. As of this date, one half of this has been collected. For fiscal year 12-13, \$22,629.25 was collected for Sales and Use Tax. Through November 2013, an amount of \$5,042.05 has been collected for Sales and Use Tax.
