Tom Wynn asked the Board if Lakemont Shores landowners would receive notification as they did when Mayes County deannexed their water system out of Delaware County. Ron Hartman stated that he had lived in the Lakemont Community since 1976 and the Lakemont HOA Board that is in place at this time has ruined the involvement of property owners, the clubhouse where meetings and events were held in the past has been vandalized by members from the Board, leaving the Lakemont Community in disarray. Sharon Greaves stated that the Lakemont Shores Board disregards the covenants and by laws that were originally set up for the community. The Board of Commissioners stated that they could not address any of these issues until the public hearing which would be set at a later date. Duke Ducommon responded that the landowners realize that and thanked the Commissioners for letting them state their grievances so they would at least make it into the newspaper for the public to be aware of what is going on.
