The courthouse hours are the same as was reported last week. Cossairt has been gathering guidelines about out of state travel and rules for employees returning to work after out of state travel. Cossairt reminded that telemedicine is available to employees.

District Attorney Kenny Wright said that there was no new guidelines from the governor. He said we are getting closer and that he had spoken with Judge Denney and we do not want to get in a rush and need to wait a couple of weeks to see if there is a bump in COVID cases from the Memorial Day holiday. There is a need to track to trend

in numbers and make sure the numbers are being accurately represented from a statistical standpoint. Commissioner Poindexter said that he had spoken with the mayor of Jay who said that the Community Center in Jay will remain closed until June 15. There is no definite date as to when the Community Center is safe to re-open.

Motion carried Sheriff Moore said the funds would be used to pay maintenance dues for the x-ray machines and other maintenance items as well as two new trucks costing approximately \$55,000 which did not include outfitting them. Commissioner Martin said that he had a problem using payroll funds for something other than raises for employees. Sheriff Moore said that if he gave raises, he could not be assured that he would be given money in the next budget to sustain the raises. Commissioner Moore said that he has an excess amount of money in payroll accounts due to the shortage of staffing because he was losing employees to counties and municipalities paying more. Commissioner Martin asked that the board receive an itemized list of items that the sheriff's office is wanting to pay for the commission to review. Commissioner Martin also said that would get with the County Assessor to see if she could estimate what the county funds would be for the next fiscal year. Commissioner Poindexter asked how many employees the Sheriff's Office currently has. Sheriff Moore said that there are currently 43. Commissioner Martin made a motion and was seconded by Commissioner Kirk to table this item until June 9. Roll Call: Commissioner Poindexter-yes Commissioner Martin-yes Commissioner Kirkyes Motion carried.
