Vicki Cossairt, HR Director, reported that cases continue to increase with 683 diagnosed cases, up 45 from last week, 23 deaths no increase, 581 recovered, up by 51 active cases 79 which was down by 6. County Risk Level Orange currently. CDC guidelines direct anyone exposed to someone with COVID should be tested regardless of exhibiting symptoms. Best practice especially since holidays coming up, do not share food or utensils. Encouraged to review mental health due to possible impact to personnel resulting from isolation or additional stress, make the public aware of the resources and where to find them if needed. The hours of the courthouse offices are unchanged.
