Vicki Cossairt, HR Director, reported that there are 1130 diagnosed cases of COVID up 265 from last week; 27 deaths increase from last week 1; 861 recovered up by 196 last week; 250 active cases which is up by 68. Reminders to have Pneumonia and Flu Shots and pertussis. Courthouse filters were changed by B&B Heat/Air, continuing to sanitize by staff to save money.

First Question from Mike Major regarding how the budget is formulated, is there consideration for current run rate by departments before the budget is put together? Commissioner Poindexter responded to confirm the process with departments in the event of increases requested to determine validity of those amounts, they have at length discussions and review previous balances to ensure necessary estimate of needs. It was determined that the Sheriff's Department had an increase over last year's budget. District Attorney Kenny Wright also responded to Mr. Major's question to confirm that the budget is created from actual balances from the previous annual budget amounts and prepared by a Certified Accountant.

Second Question from Mike Major, when and where is the budget published? County Clerk Barbara Barnes responded that the budget, once approved will be published in The American and the Journal tomorrow 10/21/2020, also the full budget, once State Auditor approved will be posted on the State of Oklahoma Website for viewing approximately a two-week time frame.

AGENDA #13-A motion was made by Commissioner Kirk and seconded by Commissioner Martin for approval for discussion of a State contract quote in the amount of \$540,938.28 from Yellowhouse Machinery for the purchase of two (2) 770G Motor Graders on behalf of District #3; State Contract ID #66861. Roll Call: Commissioner Poindexter, yes Commissioner Martin, yes Commissioner Kirk, yes. Motion carried. Discussion determined that expenditures for repairs to current aged equipment ranges from \$2000 to \$3000 an occurrence with a current outstanding Transmission repair needed that is \$16,000. Commissioner Kirk indicated it would be more cost effective to make a monthly payment of \$2500/each for new equipment to eliminate repairs and utilize the warranty in the event the new equipment would need a repair. Financing would be approximately \$5,008.84/month for 72 months for both Graders. If the bid is accepted, delivery of the equipment could be as early as 30 to 40 days.
