Reminder to have Flu Shot an to make sure Pneumonia vaccinations are current. Courthouse hours remain reduced and visitors by appointment only. Prediction of skyrocketing cases due to Thanksgiving and holiday gatherings, continue to social distance and proceed with caution to avoid contracting.
