DECEMBER 15, 2020

AGENDA #5 - A motion was made by Commissioner Kirk and seconded by Commissioner Martin for approval to conduct Public Hearing in the matter of reserving that portion of a section line easement (commonly known as East 300 Road) West of South 590 Road to the point said section line easement meets Grand Lake 'O the Cherokees, a distance of approximately 830 feet. Roll call: Commissioner Poindexter-yes, Commissioner Martin-yes, Commissioner Kirk-yes. Motion carried.

Public comments received from: Nelson Johnson, Gary Martiney, and Sarah Shafelt to voice their concerns. Mr. Johnson indicated many in the neighborhood benefit from the lake access and blocking the access would deprive citizens and visitors from these benefits and is vehemently opposed to it and appreciates the BOCC "NO" Vote in the matter. Mr. Martiney indicated he thought that the GRDA would have to give final approval since you cannot block access based on his understanding, so the BOCC alone could not make the determination. Mrs. Shafelt indicated the lack of communication to the local adjoining residents and was concerned that at some point the area if blocked off would be made into a commercial development and she and other neighbors she spoke on behalf of were opposed to that possibility. Commissioner Martin indicated receiving multiple phone calls from concerned citizens and wants to confirm the status of the road before a determination could be made on his part. It was determined the road is on Delaware County Road inventory with ODOT but not being maintained by Delaware County. The owner of the property in question voiced his concerns and provided photos of the most recent accident where a vehicle had driven into the lake 11/20/2020 and another 10/14/2016 and alluded to additional cases. He is concerned for potential further harm if nothing is done. He also voiced his concerns regarding trespassers that are intoxicated and causing noise disturbances and possible security issues. 69 OK Stat § 69-1201 (2014) was referenced and further clarification as to the status of the section in question be made before a determination is made.

A motion was made by Commissioner Martin and seconded by Commissioner Kirk to table the item until the next BOCC meeting on 12/22/2020 so further research could be made on the current status of the section line easement in question. Vicki Cossairt, HR Director, reported that there are 2382 diagnosed cases of COVID up 267 from last week; 39 deaths no change over last week; 1928 recovered up by 152 from last week; 415 active cases up by 115. She attributes the spike from the gatherings over Thanksgiving. Courthouse is continuing to maintain reduced schedules and rotating staffing to ensure safety of staff. EM Director Travis Beesley is continuing the daily sanitizing potentially saving the County \$15,000 ton \$20,000 if it was contracted out to a commercial service. Vaccines are beginning to be issued across the country beginning with the elderly. Hopefully by the New Year the #'s will begin coming down.
