Numbers continue to trend in the right direction. Johnson & Johnson was approved to be a vaccine provider so we will see them soon. All County Courthouse offices will be returning to normal full hours beginning next week. The courthouse will still maintain social distancing for the health and safety of the public and personnel so the front doors are locked basically visits are appointment only.

Commissioner Callihan worked with the town of W Siloam for additional research as well as speaking with the State EM Director to confirm that the Grant is still active that was initially available for the project at the outset, but that it will run out shortly for the amount of \$13,245 – they require the invoice to be paid full then grant will reimburse it back to the County. Commissioner Poindexter inquired for authorization from District Attorney Mr. Wright to proceed with the payment of the invoice since it is not typical to pay for another entity project. After the DA reviewed the additional information provided by the County Clerks' office as well as following up with the State Auditors' office for best path to proceed in this A-typical situation, their directive since the employee of Delaware County is no longer employed that it would be appropriate to pay the invoice.
