Vicki Cossairt, HR Director, reported that there have been 4618 diagnosed cases of COVID increased by 24 from last week 5 less than the previous week; 91 deaths increase of 1 from last week; 4494 recovered increased by 98 from last week up by 78 from the previous week; 33 active cases decrease of 75 from last week. For ongoing vaccination sites, I have brought a sample of the information provided on the Health Department Facebook pages for Ottawa County and Delaware County for the ongoing vaccination locations as well as the type of vaccine being offered at that site, Moderna or Pfizer as well as 1st and/or 2nd dose information. Most locations are taking walk-ins now as well. The numbers are trending down nationwide according to Jeff Reeves EM Director, and reference that Dr. Fauci Chief Presidential Medical Advisor indicated things getting back to normal.

Chairman Poindexter Indicated his wish to remove the mask mandate to each individual's preference and posed the question to the other Commissioners and they both agreed. Chairman Poindexter inquired of Kenny Wright District Attorney if masks were still necessary in light of the lowest numbers since the pandemic as well as the Governor indicating Oklahoma no longer in a state of emergency. The DA indicated the Courts follow the lead from the BOCC to modify their procedures at that time. Chairman Poindexter inquired of EM Director in the event we had a resurgent do we have plenty of PPE on hand if the masks need to be handed out again and his response was plenty of masks, (only using roughly 100/week at the Courthouse entrance) more than enough Tyvex suits and shields, gloves may need to be ordered. Jeff Reeves EM Director indicated as an additional precaution to move forward with the purchase of the touchless temperature scanning and if someone enters with an elevated temperature, we can take necessary precautions.

Susan Duncan will speak with Judge Denney to confirm either way and bring an update for next week's meeting
