MAY 18, 2021

Vicki Cossairt, HR Director, reported that there have been 4631 diagnosed cases of COVID increased by 13 from last week; 91 deaths no change from last week; 4521 recovered increased by 27 from last week; 19 active cases decrease of 14 from last week. Numbers are still continuing to trend down. Child tax credit up to \$300 a month coming July 15th, IRS announces. The expanded child tax credit from the Coronavirus Relief bill will be issued by direct deposit every month through the end of 2021. \$300 per month for each child under age 6 and up to \$250 per month for each child age 6 to 17, subject to income guidelines. Monday May 17th, Governor Stitt announced an end to the \$300 additional federal aid in unemployment and a \$1,200 incentive for certain individuals who get off unemployment and go back to work. Please continue to check local health department websites and Facebook for ongoing vaccination sites and their schedules, they are offering Moderna and Pfizer vaccines. EM Director Jeff Reeves knows of no PODS being currently held or any scheduled for the week.
