AGENDA #6-A motion was made by Commissioner Kirk and seconded by Commissioner Callihan to approve Hearing Human Resources Vici Cossairt on current status regarding families first Coronavirus. Roll Call: Commissioner Poindexter-yes and Commissioner Callihanyes. Motion carried. Vicki Cossairt, HR Director, reported that there have been 4712 diagnosed cases of COVID increased by 25 from last week; 94 deaths no change from last week; 4587 recovered increased by 17 from last week; 31 active cases increase of 8 from last week. We keep seeing numbers slowly rising. It's interesting on the color map for the state that Delaware County is still yellow and Ottawa County was still yellow on June 1st but they are now back to orange alert for Covid cases, nothing to worry about but to be aware of since they are so close to us – EM Director Jeff Reeves and I were comparing notes between industries we are both aware of in Ottawa County where people have come to work diagnosed with covid and were sent home approximately 20 occurrences right on our border, we should be aware of since they are right on our border. Freeman Hospital ICU is still primarily for ICU cases but some they have seen a bit of an increase of covid. EM Director Jeff Reeves was kind enough to get some statistics from the Health Department of total people fully vaccinated in Delaware County is 9720 which is 22.6% of our population which is extremely low to see people in large gatherings with no masking. So, with the new variant making its way across the country and the upcoming 4th of July holiday we may see our numbers spike again. I have some required training for all supervisors to attend especially DOT supervisors it is a required annual training that we normally have to travel to attend and the cost per person typically \$100 - \$300 per person and this is will be a one-time cost for whole group of \$90 a real bargain and Ottawa County is welcome to attend to gain the savings as well. Possibly after the first of July and the Fiscal year will schedule the training. Available in person or zoom depending on how we want to have AAVCOR facilitate for us. AGENDA #7-A motion was made by Commissioner Kirk and seconded by Commissioner Callihan for approval to discuss and review the County's policies in relation to Covid-19 and take action to modify those policies as needed. Roll Call: Commissioner Poindexter-yes and Commissioner Callihan-yes. Motion carried. Chairman Poindexter indicated keeping an eye on cases to see if they will start ramping back up but no changes as of now. He asked Vicki Cossairt, "is the variant the new variant coming in from India?" Her response is the variant being seen on the national news. She is not sure if it is actually here yet. It's still a good idea to wear masks since there is no evidence to show that even if they are vaccinated, they cannot carry it as well as still contract it. Wash your hands and be aware of social distancing.

Roll call: Commissioner Poindexteryes and Commissioner Kirk-yes. Motion carried. At this time no changes unless the numbers start going up. Commissioner Poindexter also had questions regarding the variant from India and if it is any cause for concern in our area? No one had any data for it yet.

AGENDA #8-A motion was made by Commissioner Kirk and seconded by Commissioner Callihan for approval of resolution #21-622 for acceptance and participation in the American Rescue Plan Act that was signed into law 3-11-2021. First distribution received to be deposited according to U.S. Treasury Guidelines. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Kirk-yes. Motion carried.

AGENDA #9- A motion was made by Commissioner Kirk and seconded by Commissioner Callihan for approval of resolution to execute the agreement establishing the interlocal agreement with ACCO-SIG, and the County agrees to be bound by the provisions and terms of the interlocal agreement and documents governing ACCO SIG. The 2021-2022 renewal quote is in the amount of \$368,149, increased by 20% from last fiscal year. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Kirk-yes. Motion carried. Chairman Poindexter indicated a pricing increase across the state in part due to claims as well as the average annual increase due to rising costs overall equipment and property, etc.
