AGENDA #4 A motion was made by Commissioner Kirk and seconded by Commissioner Martin to hear Human Resources and Emergency Management Report on current status regarding Families First Coronavirus. Roll Call: Commissioner Poindexter-yes Commissioner Martin-yes Commissioner Kirk-yes Motion carried.

Vicki Cossairt, HR Director reported:

- 1. Governor Stitt has approved implementation of Open Up and Recovery Plan Phase I. Phase I continues Safer at Home guidelines for those greater than age 65 or a part of a vulnerable population.
 - Social distancing remains in effect and adherence to CDC guidelines remain in effect. Business that may reopen during Phase I are personal care businesses, such as hair salons, barbershops, spas, nail salons, and pet groomers.
 - State parks and outdoor recreation

- Grocery stores should continue to maintain hours for vulnerable populations
- Retail and other essential businesses are open and may operate per Governor's Executive Order.
- 2. Delaware County remains on a reduced work schedule utilizing only essential staff as per plans developed by each department. This is being reviewed weekly. Research on best practices is being conducted on how to best transition back to full staff in house and what actions may need to be taken to provide safety at optimum levels for employees.
 - County Clerk-working in office until 2pm M-W. Working remotely Th and Fr.
 - Court Clerk and Treasurer-half staff working M-Th one week and second half of staff working M-Th the next week. Closed on Fridays
 - County Assessor Offices will be open M-Th. Closed Friday. Some staff members are working remotely.
 - County Election Board. Only 1 person at a time inside the offices with offices disinfected between each visitor to the office.
 - Judicial Working remotely until further notice
 - DA Essential staff in office M-F. Others working remotely
 - Law Enforcement Sheriff Office—administrative personnel 1 will be in the office. The other 2 working remotely. All other law enforcement working
 - County Road Crews primarily working. There are some administrative personnel working remotely. There are 3 requested furloughs in 1 group.
 - Court House no public entry. Documents may be left at the door with the guard.
- 3. As of this time no requested leaves under the Families First Act—4 furloughs have been requested and approved
- 4. Number of new cases continues to increase. Deaths increase. Large portion of new cases and deaths have been attributed to a local long-term care center.
- 5. Mental Health Issues may contact State Department of Health at 1800-955-5990 or 1800-985-5990 Disaster Distress Helpline Oklahoma Department of Health. County employees have mental health coverage as part of the healthcare benefit.
- 6. OK State Dept of Health conducting drive by screenings. Review the web site for the county or state for details.
- 7. Stimulus checks for automatic deposit have started to arrive.
- 8. Those on furlough receive an additional \$600 per week assistance included with their unemployment from federal.
- 9. Telemedicine is available at no cost to employees. COVID tested paid in network without requirement to meet deductible. Refer to Health Choice Benefits app or e-mails from Health Choice for Details
- 10. An antibody test may be available. There is no immunity to COVID but this test may be an indicator if the virus has been present and no symptoms. Availability is not yet known nor cost, though I understand that Health Choice will pay for this test at in network. Out of network incurs balanced billing.

Travis Beesley, EM Director reported that he did get his request in for assistance from OEM (Oklahoma Emergency Management) due to the COVID-19. Beesley was able to get the information needed to start receiving EMPG funds that had been withheld. He is still picking up PPE's in Wagoner and Coweta for Delaware County.

Sheriff Harlan Moore reported that he is applying for a COVID-19 equipment grant. District Attorney Kenny Wright asked if this was the grant through the Oklahoma District Attorney Council. Sheriff Moore said yes and that it is a good deal and will help out in the jail.
