Vicki Cossairt, HR Director, reported that there have been 7274 diagnosed cases of COVID increased by 94 from last week; 159 deaths increased by 20 from last week; 7016 recovered increased by 101 from last week; 99 active cases decrease of 40 from last week. In regards to the large increase in deaths we have seen where the CDC adjusts those numbers due to other comorbidities related to covid deaths, I am confident this is the reason for the large increase but will confirm with the Health Dept. Big improvement on active cases. The numbers are still slowly trending down. We'll see Halloween at the end of the week so we don't know what that holiday will bring. Historically we see rises after a holiday. Reminder its flu season if you are inclined, please remember to get your Flu vaccination and also if you are inclined, please get your Covid vaccination.

CDC also announced that they are expecting final approval this week for vaccines for children ages 5 to 11.
