Vicki Cossairt, HR Director, reported that there have been 7327 diagnosed cases of COVID increased by 53 from last week; 160 deaths increased by 1 from last week; 7084 recovered increased by 141 from last week; 83 active cases decrease of 16 from last week. The numbers overall are moving in the right direction. The FDA approved Pfizer emergency vaccinations for children ages 5 – 12. Delta Variant – Delta Four is stronger and faster spreading, but it has not crossed the ocean to the U.S. yet. There have been approvals to mix and match the vaccinations although I'm not sure who wants to do that.
