Vicki Cossairt, HR Director, reporting has changed on the State Health Dept. website so the numbers are a little bit different this week based on those differences. The totals have to be manually calculated for each zip code in the county. Total cases 9,998; total deaths 196; total recovered 9,672; total active cases are 130. I know that's up a little bit higher than the last reporting and there may be more increases due to the holidays. Delaware County Oklahoma color coded risk level has changed back to moderate Orange for the last couple of weeks. 50.9% of Oklahomans are fully vaccinated. 61.3% are partially vaccinated. CDC has approved boosters for all individuals 18 and up.

AGENDA #10- A motion was made by Commissioner Callihan and seconded by Conley Chesney (designee) for of cost sharing agreement between the Tulsa Metropolitan utility Authority and Delaware County to share a mutual support for the infrastructure maintenance project to chip and seal County Road 458 for a total of (6) miles, starting at Highway 59 and ending at County Road 641 in Delaware County, OK. TMUA agrees to pay an amount up to \$275,000 to purchase materials for the project. District #2 Commissioner Callihan shall provide labor, equipment, transportation and services to complete the project, beginning May 2022 30-day duration, weather permitting for completion – contract #136672. District #2 Commissioner Callihan indicated reaching out to the City of Tulsa via Jennifer Lindly, for assistance with maintenance of road. The City of Tulsa was willing to help since they utilize the road. The section of road is known locally as, "The Giggin Road leading to Piney Church". Commissioner Callihan is very thankful for their willingness to help.

John Vasquez present on behalf of Yellowhouse, to bring clarification and answer questions regarding the graders. The previous Dist. 3 Commissioner Martin Kirk was in discussions with John regarding a couple of used graders and they were brought over on loan until the decision could be made since they were really needed. The approximate cost for the equipment is 185,000 for each and Mr. Vasquez visited with Welch State Bank and their financing was the best with a monthly payment of \$1608 for each. It is Yellowhouse normal practice to loan out equipment to the counties any time they are needed. They have an agreement for all equipment, to indicate receipt of them upon delivery and each is marked as either on loan/demo/rental. Will clarify insurance information with ACCO as well as initiate the normal bid process to move forward with next steps. The Board appreciates Mr. Vasquez assistance and coming to the meeting today.
