AGENDA #4 – A motion was made by Commissioner Callihan and seconded by Conley Chesney (designee) to approve Hearing Human Resources Vicki Cossairt on current status regarding families first. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Conley Chesney (Designee)-yes. Motion carried. Vicki Cossairt, HR Director, 64 active cases which is up by 31; 3354 recovered up by 19; and deaths remain the same. Across the state and the nation, we are hearing that the numbers have significantly gone up. Right now, as of the 13<sup>th</sup>, I pulled the CDC report and there are no Omicron cases reported in Oklahoma. In California and New York, they are masking indoors because of the Omicron variant. Please remember to take precautions, 5 years and up can vaccinate and 18 and up can take the booster. Wear masks, wash hands and maintain your distance. It's a little bit more difficult in the holiday season with the parties and family gatherings, those are probably why we are seeing some of the numbers come up. We have another three weeks of holidays and parties and hopefully after that we will see the numbers go back down.

AGENDA #5- A motion was made by Commissioner Callihan and seconded by Conley Chesney (designee) for approval to discuss and review the County's policies in relation to Covid-19 and take action to modify those policies as needed. Conley Chesney (designee) for District 3, indicated he did not bring the information with him to the meeting. He is working with the Cherokee Nation on projects that Martin Kirk the previous commissioner initiated with them, projects totaling approximately \$150,000 that they have agreed to assist with and these are in conjunction with the tribal program.

AGENDA #7- A motion was made by Commissioner Callihan and seconded by Conley Chesney (designee) for approval of invoice in the amount of \$405.00 submitted by Greene County Sheriff's Office for housing Delaware County inmates for November 2021. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Conley Chesney (Designee)-yes. Motion carried. Captain O'Neal with the Sheriff's Department indicated that we should not have been charged. There is a (10) day allowance to pick up an inmate and they picked the inmate up on the 9th day based on the reports.

A motion was made by Commissioner Poindexter and seconded by Commissioner Callihan to decline invoice in the amount of \$405.00 submitted by Greene County Sheriff's Office for housing Delaware County inmates for November 2021 since the inmate was picked up within the 10-day allowance. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Conley Chesney (Designee)-yes. Motion carried.

AGENDA #11- A motion was made by Commissioner Callihan and seconded by Conley Chesney (designee) for approval of discussion with possible action to allow the Eucha Fire Department to purchase uniforms with tax funds. The Board approved the purchase of uniforms as long as they are for the Fire Department personnel only and they have the proper reflectivity on them and also Jeff Reeves EM Mgmt Dir indicated NFPA standards for uniforms for them to reference when ordering.

Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Conley Chesney (Designee)-yes. Motion carried. They are replacing the two members that retired.

AGENDA #13-A motion was made by Commissioner Callihan and seconded by Conley Chesney (designee) for approval of discussion with possible action of the bid received by Germinator to disinfect and sanitize the courthouse/jail, 911 building/courthouse annex, election board, Sheriff's Office, Health Department, Library complex and all three Dist. Barn Offices. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Conley Chesney (Designee)-yes. Motion carried. Commissioner Poindexter indicated the equipment is for air sanitization, mold and bacteria for health and safety for all public and personnel mitigating Covid. Commissioner Callihan inquired if this is a 100% ARPA allowed expenditure? He also inquired since the Sheriff's office and Election Board are not owned by the county, does permission need to be acquired before installation? Are there any extra filters included with the quote of \$49,295? Commissioner Poindexter indicated, none included. Does the company do duct cleaning before installation? Commissioner Poindexter indicated no they do not. Board agreed duct cleaning should be done before the installation. Commissioner Callihan inquired if the duct cleaning would be an ARPA approved expenditure? Yes, an approved expense.

Vicki Cossairt HR Director reminder of the Annual supervisor and Drug training required by DOT, today in the Commissioners Meeting room for the Commissioners, foremen, and law enforcement. James Beck Undersheriff announced a meeting open to the public next Tuesday at the Grove Performing Arts center at 6:00 p.m. anyone can come and ask the Delaware County Sheriff's office questions about their communities and list their concerns. The meeting is to provide more accessibility and increase transparency to the community. Wayne Garrison board member with the Eucha Fire Department indicated a possible safety hazard in regards to a culvert near his home by a church that needs someone to take a look at it. Also, the Eucha Fire Dept wants to sell a truck that they received a grant for back in 2001. District attorney indicated the process to submit a surplus request for board approval and the funds from the sale of the equipment would go into the fire dept account. Mike Major stated Teresa Gross in the Delaware County Clerk's office is a helpful resource to assist with the Eucha Fire Department insurance questions.
