JANUARY 4, 2022

Vicki Cossairt Human Resources Director first thing I'd like to say we've been through Thanksgiving, Christmas and New Years and I'd like to thank on behalf of all of us of Delaware County – our Law Enforcement, Dispatch and Road Crews, those who were out in inclement weather and those who were working during the Holidays and away from their families while they were taking care of all of us of Delaware County. Weekly HR report: We hired (2) patrol deputies, and one more we should know by tomorrow if he accepted our offer; (1) exit in District #3; (1) exit in dispatch; (1) transfer between road crews. I would like the Board to know this year all officers in the jail are required to have TB testing annually and we completed it on time with the help of Katie Rothrock, we appreciate her efforts. Mike Major – I just want to set the stage set for the year based on my attendance at previous meetings and missing assets and things of that nature. I encourage you to absolutely review the County Wide Controls document and try to implement Key Check points, in regards to how you manage the County. The first line item on the document is the Checklist for Quarterly Officers meetings, which I believe means all the team of the county as opposed to just the Board making all decisions.

Active cases 66 up by 7; no new deaths; the recovered total is 3458 up by 40 and we also went back up to color phase orange. The numbers may increase over the next few weeks since we are following the holidays. January 7th is the verbal hearing for the OSHA mandate that is supposed to go into effect on January 20th. Once we hear that ruling, we will determine the implemented compliance policy for employees that will have to prove they are vaccinated. Items will be sent to District Attorney Kenny Wright for review in preparation. Oklahoma is one of the 17 states that does not wish to participate in the mandate. Dr. Fauci indicated changes to isolation guidelines since he has indicated the Omicron variant being less harsh. Isolation down from 10 days to 5 days.

Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Conley Chesney (Designee)-yes. Motion carried. Josh Cantwell, COO of Grand Lake Mental Health Center, Inc thanked the Board for placing them on the agenda today, they are excited to talk about the application. Recently we submitted an application for ARPA funds in Delaware county for assistance with the "Safer at Home" initiative that they have been undertaking for approximately two years. GLMHC began a model approximately 4 years ago providing access, to decrease the barriers to the people we serve. We began supplying families with ipads with a custom application - they provided a HIPAA compliant method for them to access treatment 24 hours/day. At that time the goal was to decrease crisis episodes and to get people access to help for when and where they needed it. We have been having very good results. We decreased inpatient hospitalizations by around 80% which is a bigger decrease even than other areas of the nation. During that time period of serving approximately 1,000 clients with only 150 of those with ipads when Covid hit. The goal before Covid was a 5 yr. plan to continue to provide additional ipads for clients. When Covid hit, clients stopped coming to clinics due to Covid exposure concerns. The process had to be expedited. The application we submitted are those numbers and costs between 4/8/20 - 6/25/21 of the 726 ipads issued in Delaware County. Of that number 490 are qualified under ARPA guidelines for socioeconomic status and mental health vulnerability by providing access to daily mental health services along with the 24-hour crisis services in a nutshell. Commissioner Callihan inquired 1. how they are funded? The Dept of Mental Health and Substance Use Services and Medicaid. 2. You don't turn anyone away? No one is turned away; care coordinators will find available services for any that are over qualified for their services also some private insurances are accepted. 3. Do you plan to build a facility in Jay? Currently they do have an office in Jay in the old Cherokee hospital building and will be providing a 24hour crisis center as well within the next 18 to 24 months. The application they submitted was for \$422,059.40 in grant funding. Commissioner Poindexter indicated some confirmation of totals for the overall ARPA program needing to be finalized and then the amount would be determined for approval for GLMHC. Commissioner Poindexter thanked them for their time and for their service to the community.

The Jay Elementary PTO raises funds for three different groups that provide food to local children that are vulnerable.
