THE **BOARD OF COMMISSIONERS** OF DELAWARE COUNTY, OKLAHOMA, WILL MEET **IN REGULAR SESSION AT 9:00 A.M. ON MARCH 15, 2022**, IN THE COMMISSIONERS' PUBLIC MEETING ROOM AT 327 S. 5TH ST., JAY, OKLAHOMA IN ACCORDANCE WITH **25 O.S. SECTION 304.3**. THE BOARD OF COMMISSIONERS OF DELAWARE COUNTY IS HEREBY AUTHORIZED TO DISCUSS, CONSIDER AND TAKE POSSIBLE ACTION FOR APPROVAL, DISAPPROVAL OR TABLING OF THE FOLLOWING AGENDA ITEMS. CONSIDERATION AND POSSIBLE ACTION UPON A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL ELECTION PROCLAMATION CALLING AND HOLDING A COUNTYWIDE ELECTION ON JUNE 28, 2022, FOR THE PURPOSE OF SUBMITTING TO THE ELECTORS OF DELAWARE COUNTY, OKLAHOMA, FOR THEIR APPROVAL OR REJECTION, THE QUESTION OF EXTENDING THE EXISTING DELAWARE COUNTY, OKLAHOMA SALES TAX OF ONE HALF OF ONE PERCENT (1/2 OF 1%) CURRENTLY LEVIED UPON THE GROSS RECEIPTS OR GROSS PROCEEDS DERIVED FROM ALL TAXABLE SALES WITHIN THE COUNTY, WITH NO INCREASE IN SALES TAX RATE, FOR AN INDEFINITE PERIOD OF TIME OR UNTIL REPEALED BY THE VOTERS OF DELAWARE COUNTY AS REQUIRED BY LAW. THE PROCEEDS OF SAID EXTENDED BUT NOT INCREASED SALES TAX TO BE UTILIZED FOR COUNTY TRANSPORTATION INFRASTRUCTURE PURPOSES, INCLUDING BUT NOT LIMITED TO ROAD AND BRIDGE CONSTRUCTION, OPERATION, REPAIR, AND MAINTENANCE, AUTHORIZING THE PLEDGING OF THE SALES TAX REVENUES FOR THE PAYMENT OF DEBT SERVICE, IF APPLICABLE.
- 15. CONSIDERATION AND POSSIBLE ACTION OF AGREEMENT TO PAY 25% MATCHING FUNDS IF AWARDED \$150,000 GRANT TO UPDATE THE DELAWARE COUNTY HAZARD MITIGATION PLAN. THE GRANT WILL BE THROUGH THE DEPARTMENT OF HOMELAND SECURITY. THE COUNTY'S PORTION WILL BE \$37,500 AND COME FROM 0001-1-2000-4110 (CAPITAL OUTLAY).
