

## **DELAWARE COUNTY COMMISSIONER'S MEETING MINUTES**

## August 9, 2022

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on August 9, 2022. AGENDA #5- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve all monthly reports submitted by officers. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Beck-yes. Motion carried. Reports were submitted by the Election Board and Court Clerk.

AGENDA #6 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck for approval of citizen's participation or comments. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. There were none.

AGENDA #7 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve report by Human Resources Director Vicki Cossairt. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Cossairt said as of July 31, there were 55 active Covid cases reported in Jay and 69 in Grove. She said these are only the reported cases and with school starting, it is important to keep up a PPE regimen. Poindexter asked about the isolation rules for the newest variant. Cossairt said for vaccinated people, 24 to 48 hours isolation, then people may return to work with a mask for five days. "If they are not vaccinated, it's the same rules as before," Cossairt said.

Concerning human resources, Cossairt said two new employees have started in the Sheriff's Office. There are still 12 jobs open county-wide. The amount the county pays for benefit premiums has increased to \$24.04 per person each month. Life insurance premiums have increased \$1 per person per month. Cossairt said this increase will amount to \$3,700 more each each month the county must pay for employees' provided insurance.

Cossairt said the county is required to have a mental employee assistance program since some of the jobs are high stress and high risk. She said Grand Lake Mental Health has provided Sheriff's Officers with Ipads courtesy of a grant from Covid funds. "Officers can push a button for an EDO or for themselves," Cossairt said. The officer can receive 10 mental health visits free with total autonomy. Cossairt said this is important because many employees feel there is a stigma attached to mental health. She said it may be possible to extend this program to all county employees. She asked the board to support her pursuing the cost and details. Poindexter asked if this service would require a contract with Grand Lake Mental Health, and

Wright said it will. Poindexter asked if Cossairt had any idea what the program would cost. She said it will be a nominal fee. Similar programs she has administered were \$1 per employee.

Cossairt presented the commissioners with the plaque Cherokee Nation gave the county for being its Summer Youth Program Outstanding Work Site.

AGENDA #12- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve intrafund transfer from Eucha Fire Dept. Capital Outlay account to Eucha Fire Dept. M&O account in the amount of \$3,500 per Fire Chief Toby Buzzard. Poindexter said the transfer is to pay for insurance. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #13- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action approval of APRA funds for Har-Ber Village Café roof and exhaust fan in the amount of \$53,353. Beck asked if Har-Ber Village is a non-profit organization. Poindexter said the park began with an endowment which is long gone and the café is now its only year-round money maker. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #14- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to advertise for sealed bids on a commercial grade air conditioning unit to be installed at the Delaware County Courthouse. persons interested in submitting a bid are to contact Michaele Baker, P. A., located in the Delaware County Clerk's Office, Jay, OK. Bids will be opened and reviewed in meeting dated Aug. 15, 2022. Board reserves the right to accept/reject any and all bids and the right to re-advertise. Co. bid #22-23/02. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #15- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss the purchase of six 2022 Ram classic crew cab trucks in the amount of \$242,796 for the Sheriff's Office with possible action. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

"Our fleet is falling apart," O'Neal said. "We've had \$20,000 in repairs since January. We have 12 vehicles for 16 officers now, and two are broke down. In 2015/16 we got the Explorers, and now they have 120,000 to 130,000 miles. In 2018 we bought four trucks, so we really haven't bought any since 2018."

"There are four Durangos getting outfitted right now," Poindexter said. "When will those be ready?"

"One is ready, another one should be ready this week," O'Neal said.

There is a \$215,000 check prepared and registered Nov. 9, 2021, to purchase and outfit four Durangos which were bought

with Use Tax money.

Poindexter said six trucks ordered in 2020 were ordered without being approved by the commissioners, so the sheriff's office was not able to get those trucks.

O'Neal said the same state bid dealership which has been getting the Durangos ready since November told him these six trucks were ordered by someone who backed out. "What he told me and what I'm afraid of," O'Neal said, "is he thinks prices will go up \$8,000 across the board next year." Even at higher prices, O'Neal said the orders will be too numerous to get any vehicles in 2023. Poindexter asked if these trucks are at a state contract bidder and O'Neal said yes.

Callihan asked if the price includes outfitting the trucks. O'Neal said the \$242,796 price is trucks only. Callihan asked how much it costs to outfit a truck. O'Neal said about \$15,000 each, so the total bill for the six trucks is estimated at \$350,000. O'Neal said his office with get another contractor to do the outfitting, so that will be a separate contract. Callihan asked if that price included cages and O'Neal said cages can be put in. O'Neal said the trucks can have cages

installed.

Beck asked if the sheriff intended to keep the older vehicles. "Yes," O'Neal said, "we are looking to have another reserve academy. The last academy we had all became officers, so we want to have another one and keep the cars for that."

O'Neal said other counties have used ARPA (American Rescue Plan Act) funds to buy vehicles and asked if that was a possibility.

"I know we need to replace some, but I would like to start a rotation," Callihan said.

Poindexter asked the commissioner secretary to contact Floyd and Driver to see if the cars may be purchased with ARPA funds. O'Neal said he thinks the dealership will hold the vehicles until next week's meeting. Wright said he thinks it is a "minor miracle" to find this many vehicles.

If the trucks are an allowable APRA expense, \$242,796 will be used to make the purchase.

AGENDA #16-A motion was made by Commissioner Callihan and seconded Commissioner Beck to open the floor for new business. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. There was none.
