

DELAWARE COUNTY COMMISSIONER'S MEETING MINUTES

September 13, 2022

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on September 13, 2022. The agenda was posted September 12, 2022 at 8:35 a.m. and placed in the kiosk located on the courthouse lawn as well as the county website. Members of the Board present were Commissioner David Poindexter-Chairman, Commissioner Jake Callihan-Member, Commissioner David Beck-Member and County Clerk Barbara Barnes -Secretary. The Board of Delaware County Commissioners is hereby authorized to act on the following items:

The meeting was called to order by Chairman Poindexter followed by the flag salute and roll call. All members were present.

AGENDA #1 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck to determine that notice of meeting and agenda for this meeting was properly posted in accordance with the Oklahoma Open Meeting Act. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Beck-yes. Motion carried.

AGENDA #2-A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve introductions and announcements. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Beck-yes. Motion carried. Along with the commissioners and clerk, John Couch of Green Country Surveying, District Attorney Kenny Wright, Carolyn Boothe, Mike Major, Human Resources Director Vicki Cossairt, Emergency Management Director Jeff Reeves, Treasurer Susan Duncan, Deputy Brandon Houston, Genia Yeager, Shannon Anderson, Eddie Silkie, Butler Firefighter Randy Prins, Commissioners Secretary Kathy Parker and a number of Shady Acres residents introduced themselves.

Barnes said she received a letter Monday about property she had been asked to research two years ago. The Beck Mill Property at Flint, owned by the Cherokee Nation, will be put into a trust. The Nation intends to restore the older buildings, dating from the 1840s, including the mill, house, horse stalls, sheds and a cellar, along with the Joseph Beck Cemetery.

Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Beck-yes. Motion carried. Reports were presented by the Court Clerk and Election Board.

The board skipped to Item #11.

AGENDA #11- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to open with possible acceptance sealed bids on a utility vehicle on behalf of the Butler Volunteer Fire Department. Bid #22-23/06. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

One bid was received from Kubota Springdale Tractor of Grove for a 2022 Kubota RTV-XG850 Sidekick, four-wheel drive for \$16,430.37. Randy Prins of the Butler Fire Department was present to request that the BOCC approve the bid.

AGENDA #7 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck for approval of citizen's participation or comments. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Mike Major asked about the status of the estimate of needs. Poindexter said the estimate of needs is still in the works. The estimate of needs are the amounts asked for from each office used to prepare the budget.

Major asked for an update on the 911 Center. Poindexter said the next step is a meeting with surrounding counties which collects a 911 tax from cell phones. The next step is to get those funds routed to Delaware County. Reeves said soft quotes have been received on the equipment and when the project gets closer to installation, hard quotes will be presented.

AGENDA #8 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve report by Human Resources Vicki Cossairt. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Cossairt said two dispatchers and two detention officers are in the hire process. One dispatcher backed out on an offer. One dispatch and two detention officers left employment. Cossairt said the county has 130 active employees today. Cossairt said the list of people with key cards used to get into the building is reviewed periodically. She said forms will be used to let employees know one card is free, but additional cards will cost the employee \$20. "The cost to us is \$7 before it's formatted," Cossairt said. "These forms will help us keep up with key cards and who has them," Cossairt said. Insurance option period will be open soon, Cossairt said, and current employees may fill out the key card forms at that time.

Cossairt said she read an account of a department at a company who made it a practice to have birthday parties for their employees. One employee went to the supervisor and said do not celebrate my birthday with a party because I have stress and anxiety. The department did not want to leave this person out, so they had a party anyway. The employee was upset and the other employees snubbed the person. Eventually this employee, who had no disciplinary actions before the birthday incident, got fired. More than three years later, that employee's court case went to court and that person was awarded \$450,000. Cossairt said the story illustrates "EEOC is tight right now."

AGENDA #9- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to receive and file certificate of insurance verification, Board of Directors and Fire Department Officers of Leach Fire Department as follows: Bill Wells – President; Robert Miller – Vice President; Jim Sixkiller, Matthew Harker, Steven Kendrick – members; Tom Pearce – Fire Chief; Jamie Hix – Asst. Chief; Tome Pearce, Jamie Hix, Barbara Barnes – Requisitioning Officers; Matthew Harker, Steven Kendrick – Receiving Officers; Bill Wells – Inventory Officer. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #10-A motion was made by Commissioner Callihan and seconded by Commissioner Beck to review with possible action plats for Timber Trails and The Points Phase 5 per John Couch of Green Country Surveying. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Couch said Timber Trails is smaller lots and The Points Phase 5 is the latest installment of large lots. Poindexter made a motion to accept both plats. Callihan seconded the motion. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #12- A motion was made by Commissioner Poindexter and seconded by Commissioner Callihan to approve an interfund transfer from District #2 CBRI to District #2 Highway M&O in the amount of \$61,900.74 for an error correction. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #13- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to advertise for sealed bids on a used 2,000- gallon pumper/tanker truck for the Hickory Grove Volunteer Fire Department. Persons interested in submitting a bid are to contact Michaele Baker, P. A., located in the County Clerk's Office, Jay, OK. Bids will be received no later than 9/23/22 at 4 p.m. in the County Clerk's Office, Jay, OK. Bids will be opened and reviewed in regular meeting dated 9/27/22 at 9 a.m. The Board receives the right to accept/reject any or all bids and the right to re-advertise. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #14- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action purchase of four shotguns from L & L Outdoors. This is a new purchase order. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Brandon Houston said a purchase order for shotguns from L & L was closed, but the Sheriff's Office still wants to purchase shotguns from L & L. Callihan pointed out there are already 26 shotguns on the sheriff's list. Poindexter pointed out only eight of those are assigned to a person. The rest are listed as in the armory. "What about the unassigned shotguns?" Poindexter said. Houston said he doesn't know anything about the number of shotguns or who they are assigned to. He said he just knows L & L has six of the make and model they want right now, and the sheriff wants to buy them and eight more when they become available. That would make 40 shotguns owned by the sheriff's office. The sheriff's office had 38 active employees on the payroll list Sept. 13, including jailers. Sixteen of those employees were listed as deputies. The sheriff's office roster currently has 131 guns listed. No action was taken.

AGENDA #15- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to update interlocal agreement with City of Jay designating Jeff Reeves as Floodplain Administrator. Reeves said this agreement has been in place a long time. He said this is the state form and Jay has continually paid the \$500 cost for the services of the Floodplain Administrator. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #16- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve 308 monthly apportionments.

If the road is not public, he would be trespassing.
