

## **DELAWARE COUNTY COMMISSIONER'S MEETING MINUTES**

## **September 27, 2022**

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on September 27, 2022. The agenda was posted September 26, 2022, at 9 a.m. and placed in the kiosk located on the courthouse lawn as well as the county website. Members of the Board present were Commissioner David Poindexter-Chairman, Commissioner Jake Callihan-Member, Commissioner David Beck-Member and County Clerk Barbara Barnes -Secretary. The Board of Delaware County Commissioners is hereby authorized to act on the following items:

The meeting was called to order by Chairman Poindexter followed by the flag salute and roll call. All members were present.

Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Beck-yes. Motion carried. This item was skipped to give more elected officials time to arrive to sign payroll affidavits.

AGENDA #7 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve all monthly reports submitted by officers. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Beck-yes. Motion carried. Not needed since no reports were received.

AGENDA #8- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to open the floor for citizens' participation or comments. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. There were none.

AGENDA #9 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve report by Human Resources Vicki Cossairt. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Cossairt said the county currently has 138 employees. Two dispatch positions are posted, but Cossairt said she keeps a perpetual posting for each law enforcement position. A mechanic is needed in District #2, a heavy equipment operator is needed in District #1, three positions are posted for deputies and three for detention officers. Cossairt said flu season has begun and urged everyone to get current on all vaccinations.

Cossairt said direct deposit for employees has been delayed 60 days because some employees used to be paid in advance. She asked now that the county pays on the last two weeks worked, if the commissioners would consider making direct deposit available "from day one." The commissioners said they would be amenable to the change.

Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #11-A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve donation road project for Shore Drive in District #2 per Commissioner Callihan. "Some people wanted their road paved and they are paying for it," Callihan said. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Commissioner Beck-yes. Motion carried.

AGENDA #12- A motion was made by Commissioner Poindexter and seconded by Commissioner Callihan to reinstate the burn ban effective from 11 a.m. on Sept. 27 to 11 a.m. Oct. 10. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Jeff Reeves said he has polled most of the fire chiefs and all agreed the burn ban should be reinstated.

AGENDA #13 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve audit engagement letter authorizing Ober & Littlefield to perform audit of the Delaware County Educational Authority. Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #14- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action upfitting of six Dodge Ram trucks for the Sheriff's Office. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Sheriff Beck said the outfitting estimate from Dana is "\$79,000 and some change." He said this is the same shop outfitting the Durangos previously purchased for the Sheriff's Office. He referred to another estimate which was "much higher." Beck said the Durangos were purchased including the upfit package through the dealer. That was not possible when the trucks were purchased as there was a big hurry to buy the trucks before someone else did. The commissioners bought the trucks with funds from the American Rescue Plan Act. Callihan asked if radios are included in this price. The Sheriff said radios are not included. Poindexter asked if the other commissioners wanted to use funds from the Use Tax account to pay for the upfit. Both the other commissioners agreed. Poindexter made the motion to pay for the upfit out of Use Tax. David Beck seconded the motion. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #15- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve interfund error correction transfer from General Government to Use Tax in the amount of \$6,854.50. Poindexter said this amount is an insurance payment from a Sheriff's Office wreck. Since the vehicle was purchased from the Use Tax account in the first place, Poindexter said the money should be put back into that account. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #16- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to receive and file copy of certificate of liability insurance and current list of Board of Directors and Officers for the Eucha Volunteer Fire Department as follows: Leanne Buske-Chairman; Hanna Ball-Vice Chair; Wayne Garritson, Pattie Cobb-members; Toby Buzzard-Fire Chief; J.J. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #18- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve intrafund transfer from Cowskin Fire Dept. Lease/Purchase to Cowskin Fire Department M&O in the amount of \$15,000 per Chris Wilkens, Chairman of the Board. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #19- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve resolution authorizing application for financial assistance from the Rural Economic Action Plan Fund (REAP) for the Cowskin Fire Department to improve public access to the fire department. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Poindexter said Chris Wilkens was not able to get the application completed and asked the item be moved to the Oct. 4 agenda. Motion was made by Poindexter and seconded by Callihan to put the item on the Oct. 4 agenda.

AGENDA #20- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action quote submitted by Air Wise Heating and Air LLC to clean supply air grills and increase the openings of grills in the jail for better air delivery. The commissioners decided to accept the quote. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #21- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action quote submitted by Air Wise Heating and Air LLC to repair and /or replace all HVAC condensation drain lines at the Courthouse, including support brackets for the lines and relocation to a proper discharge location as well as clean all drain termination areas. The commissioners decided to accept the quote. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #22- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action preventative maintenance contract proposal for the Courthouse heat and air systems submitted by Air Wise Heating and Air LLC. Poindexter said the contract would amount to \$281 a month. The commissioners decided to accept the quote. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #23- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve ODOT claim form 342a concerning payment for the purchase of perpetual easements on J/P No. 29410(04) Project J2-9210(005)CI, parcels 1A, 1B, 1.1, and 1.2 in District #2. Callihan said this project is a bridge over Drowning Creek. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #24- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to receive additional funds in the amount of \$17,820 to be deposited into existing Crace Shores donation account 1235-6-4100-2201 per request of District #1. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #25- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to pay invoices submitted by Floyd & Driver PLLC for August and September, 2022, for American Rescue Plan Act professional services and monthly retainers. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #26- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss status of East 344 Road in the SE ½ of Section 35, Township 24, Range 22 in Delaware County, Okla.; specifically, whether the road is public or private and whether, if public, a utility easement exists; and possible action to include declaration by the Board of its determination of the status of the road and utility easement. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

District Attorney Wright said this is a part of a road in Zena along the edge of the lake that has been discussed in meetings several times. He said a developer wants to run a water line to a proposed subdivision and a controversy arose over whether the road is public or private. Wright said many employees have done research on this issue. Wright said some basic facts about the road are: it has been there over 50 years; it is not a section line road; there is no resolution on file stating the road

was adopted into the county system; the road is not on any subdivision plat, so there is no plat dedication; E 344 Rd. has had power lines in the right of way for 48 years and water lines in the right of way for 17 years; the county has been maintaining the road for at least 20 years.

Wright said this is a public road under three of the legal grounds he found. Since E 344 has been used as a public road for at least 15 years, it becomes a public road by prescription or adverse possession, even if the land it is on belongs to an individual. "Easement by necessity also works here," Wright said, "because it is the only way in and out, plus the utility easement is by necessity." Wright said the board may grant any citizen the right to use the right of way for public utilities. "I know that's the next question that will be asked of you guys," Wright said.

Wright told the commissioners they could declare the road public today and he will prepare a resolution to be signed at the next BOCC meeting so a permanent record can be recorded in the County Clerk's Office. He also asked permission the disseminate his opinion and other information.

Poindexter asked if this road is a perpetual easement no matter who owns the land. Wright said it is a perpetual easement and the resolution will make a permanent record.

Callihan made the motion, seconded by Beck, to declare E 344 a public road with a utility easement. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #27- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action repairing Sheriff's Office Unit #810, 2016 Ford Explorer in the amount of \$7,082.71. Cossairt said she has been investigating the root cause of this accident and the patrol unit has been in and out of service, has no headlights and is dented. She said the county's insurance adjuster sent an engineer generated estimate for repairs which is the six-thousand-dollar amount. She said the local estimate to make the repairs is about \$200 higher. She said the vehicle has over 100,000 miles on it, but if the commissioners will agree to pay the \$200 over the insurance check already received, the local body shop can do the repair.

Sheriff Beck said the car was let set a long time, but his office got it road worthy because it was needed and most of the damage was cosmetic. He said the insurance companies fought over which party was at fault and the county's insurance finally just said it would pay. "It's mechanically sound now, but I don't know how long that will last," Beck said. "It needs headlights because some of these cars are getting 24-hours-a-day. He said the quote is over 30 days old, so the amount to repair the car may have changed.

Callihan made the motion to repair Unit #810, a Ford Explorer, for the amount of \$7,082.71. David Beck seconded the motion. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. The money is to be taken from the Use Tax account.

Poindexter returned the meeting to item 6 for elected officials of their designees to sign payroll affidavits. Two elected officials were not present, but Callihan reached them by text and they came to the meeting.

AGENDA #28- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss county-wide Internal Controls Checklist for quarterly officers' meetings; fiscal year 2022-2023. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Officers signed in as attending included Barbara Barnes, Larena Ellis Cook, Caroline Weaver, Susan Duncan, James Beck, David Poindexter, Jake Callihan and David Beck. There was a discussion on items one and two of the check list including items related to the employee handbook. Officers agreed each employee is provided with a handbook during the new hire process and they sign an affidavit to that effect which is kept in each employee's file. The handbook outlines expectations of employee conduct and guidelines for reporting grievances.

Item #8 on page 3 of the list was addressed which asks if BOCC and other officials are taking steps to ensure compliance with state statutes and new litigation. HB 3045 was discussed which relates to the sale, trade, and disposition of county equipment; clarifying the applicability of a prohibition on when the board of county commissioners can deem property as surplus; and providing an effective date. Beginning Nov. 1, commissioners may surplus or salvage items even if it is their election year for any office other than their own. HB 3344 was also discussed, which raises the limit on inventory requirements from items valued at \$500 to \$2,500. Sheriff Beck said this will not apply to his office as each fire arm must be put on his inventory and they are less than \$2,500 each.

Item #9 asks if employees are made aware that assets of the County are not to be used for personal use. Officers discussed an affidavit is also signed concerning using county property for personal purposes and a county loyalty oath is signed and notarized and kept in the employee's file locked in the County Clerk's Office.

Item #5 on that page asks if the BOCC and other officials ensure all assets of the County are properly insured and records are updated. Barnes said she is in the process of correcting the property liability list and Parker is updating the vehicle and equipment lists. Discussion was held about how to get items on and off inventory and insurance lists. It was determined that the best and fastest way is the call ACCO to add the new equipment, or take equipment off the insurance schedule.

Item #4 on page 5 asks if FEMA information is obtained and shared with those responsible for financial reporting and monitoring of compliance for federal funds. Since all of these things are done from the County Clerk's Office, Parker said as Commissioners Secretary, she has attended FEMA's National Incident Management and Incident Command System classes over the last couple of months to learn proper procedure and reporting for federal funds. A discussion was held about a possible day or half-day meeting for all officials to get an overview of these procedures. Parker will speak to Jeff Reeves about helping to set up this training. Sheriff Beck said he has used NIMS and ICS systems in disasters and it is training that will be vital if the county has a disaster.

AGENDA #29-A motion was made by Commissioner Callihan and seconded by Commissioner Beck to adjourn at 10:28 a.m. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.
