

## **DELAWARE COUNTY COMMISSIONER'S MEETING MINUTES**

## April 4, 2023

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on April 4, 2023. The agenda was posted April 3, 2023 at 8:38 a.m. and placed in the kiosk located on the courthouse lawn as well as the county website. Members of the Board present were Commissioner David Poindexter-Chairman, Commissioner Jake Callihan-Member, Commissioner David Beck-Member and County Clerk Barbara Barnes -Secretary. The Board of Delaware County Commissioners is hereby authorized to act on the following items:

The meeting was called to order by Chairman Poindexter followed by the flag salute and roll call. All members were present.

AGENDA #1 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck to determine that notice of meeting and agenda for this meeting was properly posted in accordance with the Oklahoma Open Meeting Act. AGENDA #5 – A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve all monthly reports from officers. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Reports were submitted by the Assessor, County Clerk, Sheriff and Health Department.

AGENDA #6 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck for approval of citizen's participation or comments. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. There were none.

AGENDA #7 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve report by Human Resources Vicki Cossairt. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Cossairt said the county had 139 employees Tuesday morning. Fourteen open positions are advertised, but she said two positions were "filled this morning" and six new hires had orientation yesterday, four of which were the sheriff's office. Cossairt said the turnover percentage for the county as a whole is very low. Cossairt said this is election day and encouraged everyone to vote. She said the county has a policy to allow employees to go to the polls when they are working.

Cossairt told the commissioners the amount of vacation which can be accrued by employees is 240 hours maximum, 200 of which an employee may be paid for if they terminate. She said employees were allowed to go higher on hours during Covid, but now the policy should be brought back in line. She said she has asked the commissioners to consider this before. Cossairt said the accrued hours must be brought back into compliance by July 1. Those employees still carrying too many vacation hours should use the extra hours between now and July 1. Cossairt wants each elected official to send her a list of their employees with the number of vacation, sick and comp hours each person has earned. She said the payroll clerk can enter all that information to be printed on the check stubs. Cossairt said the maximum sick time which can be accrued is 1040. After that, the hours are lost. "Sick hours are only to be used when you are sick or for an FMLA occurrence for a designated beneficiary."

Cossairt said storms are predicted and encouraged everyone to stay safe.

AGENDA #8-A motion was made by Commissioner Callihan and seconded Commissioner Beck to open the floor for new business. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. There was none.

AGENDA #9- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to receive and file copy of certificate of liability insurance and current list of Board of Directors and Officers for the West Siloam Springs Volunteer Fire Department as follows: Joey Dozhier – President; Dave Kendrick – Vice President; Linda Stinchcomb – Secretary; Sharon Harrison – Treasurer; Bud Stinchcomb – member; Fire Chief – Bob Coleman; Asst. Chief – Misty Martin; Requisitioning Officers – Bob Coleman, Barbara Barnes; Receiving Officer – Joey Dozhier. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #10- Was not needed because no sealed bids for painting the lettering on the outside of the courthouse on behalf of Delaware County were received. Bid #22-23/26.

AGENDA #11- A motion was made by Commissioner Poindexter and seconded by Commissioner Callihan to surplus 1992 Ford F-250 pickup, inventory #FD-OK-701.1, Vin #1FTHX26H1NKB87008 per Vince Osburn, Oaks Fire Department. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #12- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve intrafund transfer from CBRI Bridge #110 to CBRI – 105-3 in the amount of \$50,000, per District 3 Commissioner David Beck. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #13-A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve an intrafund transfer from County Clerk Capital Outlay & Personal Services to County Clerk Travel in the amount of \$1,300, per County Clerk Barbara Barnes. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #14-A motion was made by Commissioner Callihan and seconded by Commissioner Beck to enter into Executive Session to hold confidential communications between the Board of County Commissioners and the District Attorney concerning the settling of certain claims in pending litigation (The County Commissioners of Delaware County, Oklahoma V. Purdue Pharm, L.P.) including potential resolution of certain claims against Walmart, Walgreens, CVS, Teva and Allergan, related to lawsuits against pharmaceutical supply chain participants of opioid prescription drugs, and taking appropriate action to in open session, including possible authorization to settle claims, the disclosure of which may seriously impair the litigation if known by public disclosure as allowed by 25 O. S. ss307(B)(4). Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Executive session began at 9:20 a.m.

AGENDA #15-A motion was made by Commissioner Callihan and seconded by Commissioner Poindexter to return to regular session for discussion and possible vote concerning any necessary action regarding Item #14 identified above at 9:27 a.m. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. No action was needed.

AGENDA #16-A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve resolutions for opioid retailer settlement agreements from Walmart, Walgreens, CVS, Allergan and Teva. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #17- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action the need to clean the air ducts in the courthouse. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Barnes said a worker hired to repair sheetrock recently said he could see the ductwork and it's very dirty. She suggested creating specs and going out for bid. Poindexter said he would get information for a vendor at the ACCO Convention later in the week. Barnes asked if bids should be solicited? Poindexter said specs should be developed first and vendors secured to send them to. No action was taken.

AGENDA #18-A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action progress concerning the fairgrounds project. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Commissioner Callihan said he has been in communication with Commissioner Hall at Cherokee County where a new fairgrounds building is almost complete. Callihan said he wants to take the steering committee and anyone else who cares to go to see the new facility.

AGENDA #18-A motion was made by Commissioner Callihan and seconded by Commissioner Beck to adjourn at 9:34 a.m. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.
