

DELAWARE COUNTY COMMISSIONER'S MEETING MINUTES

April 25, 2023

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on April 25, 2023. The agenda was posted April 24, 2023 at 8:00 a.m. and placed in the kiosk located on the courthouse lawn as well as the county website. Members of the Board present were Commissioner David Poindexter-Chairman, Commissioner Jake Callihan-Member and Commissioner David Beck-Member. The Board of Delaware County Commissioners is hereby authorized to act on the following items:

The meeting was called to order by Chairman Poindexter followed by the flag salute and roll call. Poindexter, Callihan and Beck were present. County Clerk Barbara Barnes was absent.

AGENDA #5 was not needed as no monthly reports from officers were received.

AGENDA #6 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck for approval of citizen's participation or comments. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. There were none.

AGENDA #7 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck to hear report from Human Resources Director Vicki Cossairt. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Cossairt said the county has 140 employees and in the last two weeks there has been one termination, four new hires and two new starts. One of those was an internal transfer.

Cossairt said she and Emergency Manager Jeff Reeves have been doing root cause analysis when accidents happen. Some of the reasons found were brought to the commissioners as the incidents had enough merit to warrant action. Root causes for accidents included officers using their own weapons, no first aid kits and extinguishers in police cars, radio issues and seat belt issues. The commissioners approved setting up defensive driving classes last October, to be paid for from the Use Tax account. Reeves found the training could be set up at Monkey Island Fire Department for \$500. Cossairt said last week, two training sessions were held with 12 participants in each session. Cossairt said this is the first time for this training, but she hopes the commissioners will develop an action plan to continue this training for any county employees. She thanked the commissioners, Reeves, and Monkey Island Fire Chief Carl Tesreau for setting up and funding the training.

Cossairt said the steps down to the jail and dispatch center need handrails as there is a potential for falls. She said Reeves has taken on the matter and will try to get handrails installed.

Cossairt has talked to the commissioners numerous times about employees who accrued vacation hours past the allowed number of hours which can be carried on the books during the pandemic. She said six long-time employees are still in this situation. Cossairt asked the commissioners to give those employees until December 1 to get their hours back into allowable parameters.

AGENDA #8-A motion was made by Commissioner Callihan and seconded Commissioner Beck to open the floor for new business. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. There was none.

AGENDA #9- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to sign affidavits for the April 28th payroll. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Bennie Leon French, Et Al. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #12- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to advertise for sealed bids on the replacement of fire alarm control panel for the Delaware County Courthouse and Jail. Persons interested in submitting a bid are to contact Michaele Baker, P. A., located in the Delaware County Clerk's Office; Jay, Okla. Bids will be opened and reviewed in the meeting dated May 16, 2023, at 9 a.m. Bids will be received no later than 3 p.m. in the County Clerk's Office; Jay, Okla., on May 12, 2023. The board reserves the right to accept/reject any and all bids and the right to re-advertise. County bid #22-23/30. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #13-A motion was made by Commissioner Callihan and seconded by Commissioner Beck to open sealed bids on annual extermination service with possible acceptance. County bid #22-23/20. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Two bids were received. Callihan opened one from Grand County Pest Control of Grove, who bid \$220 per month to spray the courthouse, \$50 for the annex, \$30 for the Election Board and \$25 for the Sheriff's Office. Poindexter opened a bid from Pest Off Exterminators of Claremore, who bid \$150 per month for the courthouse, \$40 for the annex, \$40 for the Election Board and \$40 for the Sheriff's Office. Callihan made a motion to accept the bid from Grand Country Pest based on experience with others who did not do the job, resulting in bug problems in the courthouse. Beck seconded. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #14- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to open sealed bids on annual janitorial service for the Delaware County Courthouse with acceptance later. County bid #22-23/21. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. One bid was received from Robert D. McCord, Miami, who is the current contractor. Callihan opened the bid which was \$3,850 per month.

AGENDA #15- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to pay invoices from Floyd & Driver for American Rescue Plan Act professional services and monthly retainer for February and March in the amount of \$7,594.54 each. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Callihan said the project is at a stand still until it becomes clear how much APRA money will be left after the E-911 Center is fully financed.
