

## **DELAWARE COUNTY COMMISSIONER'S MEETING MINUTES**

June 13, 2023

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on June 13, 2023. The agenda was posted June 8, 2023, at 2:50 p.m. and placed in the kiosk located on the courthouse lawn as well as the county website. Members of the Board present were Commissioner David Poindexter-Chairman, Commissioner Jake Callihan-Member, Commissioner David Beck-Member and County Clerk Barbara Barnes -Secretary. The Board of Delaware County Commissioners is hereby authorized to act on the following items:

The meeting was called to order by Chairman Poindexter followed by the flag salute and roll call. All members were present.

AGENDA #21- A motion was made by Commissioner Callihan and seconded by Commissioner Poindexter to approve annual paper and cleaning products bid #22-23/25. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. The commissioners accepted both submitted bids.

AGENDA #22- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss annual uniform service bid. County bid #22-23/24. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. No bids were received for uniform service, but since the total spent on uniform service does not reach the amount needed to solicit bids, each barn can choose the uniform service it wishes to use.

AGENDA #23- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve contracts for 2023-2024 fiscal year on behalf of Delaware County Health Department as follows: Debra Goff – Janitorial Services; Jay Family Medicine – Sterilization; Dr. Tidwell – Medical Director; Verizon; Pitney Bowes; All State Pest; Hometown Bottled Water; Leaf. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #24- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve County Road Machinery and Equipment Revolving Fund lease renewal and insurance verification for fiscal year 2023-2024. Roll call: Commissioner Poindexterves; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #25- A motion was made by Commissioner Beck and seconded by Commissioner Beck to discuss benefits of a county-wide implementation of ODMAP; a goal of the county-wide COSSUP grant for public safety and public health. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Kristin Tanner and Shanan Cox said an OPIOID grant is in place which is providing overdose protection maps. Tanner said anyone involved with overdose situations, mostly emergency services and police, already submits information on overdoses to a data base. This nation-wide map shows where overdoses are most likely to happen, providing a target for prevention. The grant is \$600,000 over three years. She said several county entities, including Monkey Island Fire, the City of Jay and the Sheriff have already expressed their desire to participate in making the map.

The sheriff said "this is just data mapping. Most of our information will come from dispatch. There are not a lot of overdoses here, but one is too many in my opinion."

AGENDA #26- A motion was made by Commissioner Beck and seconded by Commissioner Beck to discuss with possible action the footprint map for the Delaware County E-911 Center. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Poindexter said the size of the break room on the end of the building has been trimmed and a sink will not be included in that room. He said some other small changes such as trimming the size of the lobby to make more counter space and possibly making the emergency management offices into one room instead of two have been made.

Callihan asked if BKL handles the bidding. Poindexter said BKL develops the bid packages and will be present when the bids are opened to help select the best bid.

Poindexter made a motion to approve the floor plan, seconded by Callihan. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #27- A motion was made by Commissioner Beck and seconded by Commissioner Poindexter to discuss with possible action contract amendments for medical staffing and administration provided by Turn Key Health Clinics on behalf of the Sheriff's Office. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Rothrock said the amendments are to either continue the 20-hour per week nursing contract, or to upgrade to a 40-hour on site nurse. The contract is for 65 inmates. It is based on the capacity of the jail. Sheriff Beck said the jail generally has 90 inmates most of the time now. "The jail is just too small," Beck said. Beck said the jail has been operating at felony status only inmates for the last seven or eight months and Rothrock is working to get more inmates released on O. R. Beck said this contract does not include medicine, which he estimated at \$27,600. The 20-hour contract is \$101,416.68 per year and the 40-hour contract is \$158,616.72 per year, a difference of over \$57,000. The sheriff wants the extended contract, plus the cost of medicine, to be paid out of the county's funds. The item was tabled to the June 20 meeting.

AGENDA #28- A motion was made by Commissioner Beck and seconded by Commissioner Poindexter to discuss with possible action progress concerning fairgrounds project. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beckyes. Motion carried.

Callihan said a meeting is set with the steering committee and the architect June 21 to get ballpark figures for the building cost.

AGENDA #29- A motion was made by Commissioner Beck and seconded by Commissioner Poindexter to adjourn at 9:54 a.m. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.
