DELAWARE COUNTY COMMISSIONER MEETING MINUTES

August 15, 2023

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on August 15, 2023. The agenda was posted August 10, 2023, at 3:33 p.m. and placed in the kiosk on the courthouse lawn well as the county website. Members of the Board present were Commissioner David Poindexter-Chairman, Commissioner Jake Callihan-Member, Commissioner David Beck-Member and County Clerk Barbara Barnes -Secretary. The Board of Delaware County Commissioners is hereby authorized to act on the following items:

The meeting was called to order by Chairman Poindexter followed by the flag salute and roll call. All members were present.

AGENDA #5 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve all monthly reports submitted by officers. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. A report was submitted by the Court Clerk.

AGENDA #6 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck for approval of citizen's participation or comments. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Carl Tesreau thanked all the volunteers who helped with demolition to clear the new 911 Center for remodeling. Firefighters from West Siloam Springs, Kansas, Butler, Cleora, and Monkey Island, along with Emergency Manager Jeff Reeves, E-911 Coordinators Tracy Sixkiller and Rod Neal, and County inmates have completed the demolition. The building is now ready for construction at no cost to the County. Tesreau thanked Commissioner Callihan for keeping dumpsters in place and debris hauled away. Reeves told the commissioners the 80 percent grant reimbursement for the haz-mat plan structure has been received in the amount of \$126,585. In addition, \$390,000 has been returned from the grant to pay for 911 communications equipment.

AGENDA #7 -A motion was made by Commissioners Callihan and seconded by Commissioner Beck to hear report by Human Resources Director Vicki Cossairt. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Cossairt said the county had 135 employees Tuesday. Five new hires are in process, two of which are CDL drivers. Two employees exited last week. The county has eight open jobs posted.

Cossairt said the provider who did DOT physicals for CDL drivers has retired, so a new provider will need to be found. She said it is possible for a chiropractor to do the physicals. Poindexter said he has a possible candidate.

Cossairt said Aug, 31 is the last day for Court Clerk Caroline Weaver who is retiring after 30 years. A reception is planned.

AGENDA #8- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to open the floor for new business. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. There was none.

AGENDA #9- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to surplus and salvage an asphalt paver, inventory #D340-0100, per District #3. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #12- A motion was made by Commissioner Poindexter and seconded by Commissioner Callihan to approve Resolution for Project Agreement with ODOT for Project J3-4449(004)CI on NS 4510 and EW 270 over Fly Creek and Tributary to Fly Creek approximately 1 mile N of SH85/SH85A junction in District #1. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #13- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to salvage a 20 HP Honda portable pump, inventory #FD-WS-717.1, and a rescue bed, inventory #FD-WS-727.1, on behalf of West Siloam Springs Fire Department. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #14- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action purchasing vehicles for the Sheriff's Office. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Sheriff James Beck said he was present to open a dialog to get some help purchasing vehicles. He said eight Explorers are falling apart; the five patrol deputies are driving are "dying out," and it would cost more to fix them that to buy new ones. Beck said the Resource Officers he has placed need vehicles. Beck admitted he will soon get the sales tax money voters approved for his office alone, maybe as soon as September, but he said he needs the vehicles right now. Beck said he wants \$720,000 for vehicles set up on three to four-year financing. He said if the commissioners will make the first year's payments, "maybe" he can take them over from there. Beck said at the current interest rate, a year's worth of payments would be \$264,000. He wants the commissioners to get the money out of the Use Tax account. Beck wants 13 Durangos. He said he has found a place in Arkansas to "upfit" the vehicles, as the last place hired to do this job in Oklahoma City took forever and did not get it right.

Beck said he can get 11 Tahoes for \$720,000, but they resale better. Beck said if the BOCC will agree to this purchase, he will begin a three to four-year rotation plan.

Poindexter asked Beck to put those numbers together and get a copy ready for each commissioner. Beck said he wants to open out of state bids now. Once again, the sheriff told the commissioners he does not have the money to buy vehicles and he is asking them to "give us the money to help get us started."

Poindexter asked Beck if his budget increase will cover his payroll. Beck said yes.

Callihan asked if the budget increase and the tax money will cover payroll and the payments for these vehicles.

"Help us one year and then maybe we can take the payments," Beck said. "Course the board can pay for them up front if they want to. Just make the first payment, then we will make them."

Callihan asked if Beck has any vehicle payments now. Beck said he does not. This is because the BOCC has bought all the vehicles for the office outright so far with ARPA and Use Tax funds since Beck has been in office.

Poindexter said he is a visual person and he needs to see figures prepared on paper.

Beck said the interest to finance the vehicles for three years is approximately \$70,000.
