

DELAWARE COUNTY COMMISSIONER MEETING MINUTES

August 29, 2023

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on August 29, 2023. The agenda was posted August 28, 2023, at 8:24 a.m. and placed in the kiosk on the courthouse lawn well as the county website. Members of the Board present were Commissioner David Poindexter-Chairman, Commissioner Jake Callihan-Member, Commissioner David Beck-Member and County Clerk Barbara Barnes -Secretary. The Board of Delaware County Commissioners is hereby authorized to act on the following items:

The meeting was called to order by Chairman Poindexter followed by the flag salute and roll call. All members were present.

AGENDA #7 -A motion was made by Commissioners Callihan and seconded by Commissioner Beck to hear report by Human Resources Director Vicki Cossairt. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Cossairt said the county had 134 employees Tuesday. The county has three new hires, one employment offer was rescinded and one employee transferred from one department to another. Cossairt said a CDL driver interview for District#1 is scheduled this week. She said most of the posted positions open are for the Sheriff's Office. Cossairt said she has received the application from Karma Sapp for Interim Court Clerk. Caroline Weaver is retiring and going to the Supreme Court. She read a recommendation letter written by Weaver on behalf of Sapp, who has been working in the Court Clerk's Office 29 years.

Cossairt said she will coordinate with payroll to have longevity and safety award pay on one of the November payroll checks.

AGENDA #16- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action authorizing the District Attorney to disclaim interest of Board of County Commissioners regarding petition to vacate portion of plat and quiet title, Case #CV2023-132, Diann Whitney Et Al vs. Board of Commissioners of Delaware County Et Al. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. A motion was made by Callihan and

seconded by Beck to disclaim interest in the Skip Ross plat tracts. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #17- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve resolution for choice or replacement of E-911 Trust Board Members. This item was tabled from the Aug. 22 meeting. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Beck said he called Lance Terry, the state 911 Coordinator, who told him not to pass the resolution because a resolution cannot be passed on a trust. The commissioners asked Parker if the District Attorney approved the resolution. She said the D.A. read and approved the resolution. Callihan made a motion, seconded by Beck, to table the item until the Sept. 5 BOCC meeting.

AGENDA #18- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action accepting donation from Solid Waste Trust to Delaware County Sheriff's Office for tires for the DEQ truck, per Sheriff James Beck, tabled from Aug. 22 meeting. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Undersheriff Nick O'Neal said he was told the tires cost \$820, but he had no paper to prove the amount. Poindexter said documentation of the amount is needed before the donation can be accepted. No action was taken.

AGENDA #19- A motion was made by Commissioner Beck and seconded by Commissioner Poindexter to approve paying off a 2023 Western Star Truck, Serial #5KJJALD11PPUK8640 with Arvest Bank on behalf of District #3. Poindexter read the payoff amount from the bank document at \$154,113.28. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #20- A motion was made by Commissioner Beck and seconded by Commissioner Poindexter to pay small business grant award from ARPA funds awarded to Photography by Kathryn in the amount of \$12,000.
