The Budget Board of Delaware County met in Special Session in the County Commissioner's meeting room in the Delaware County Courthouse at 9:00 a.m. on October 19, 2015. Agenda was posted October 9, 2015 at 11:08 a.m. in the kiosk located on the east courthouse lawn.

AGENDA #1-A motion was made by Duncan and seconded by Smith to approve the minutes of the Special Meeting dated 10/8/15. Roger Crutchfield, Northeast Technology Center and Sandy Coaly, Grove Public Schools addressed the Board stating Delaware County's fees are higher than the average in the state. Larena Ellis-Cook said that she had looked at the comparison and said those were fees were not only for visual inspection but also covered the appraisals that were involved with each parcel. Ellis-Cook also stated that she would be looking at the average fees of counties having similar numbers of parcels as Delaware County as well as the average of counties that had passed annual state performance audits. 


