

## **DELAWARE COUNTY COMMISSIONER MEETING MINUTES**

## January 16, 2024

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on January 16, 2024. The agenda was posted January 11, 2023, at 4:30 p.m. and placed in the kiosk on the courthouse lawn well as the county website. Members of the Board present were Commissioner David Poindexter-Chairman, Commissioner Jake Callihan-Member, Commissioner David Beck-Member, and County Clerk Barbara Barnes. The Board of Delaware County Commissioners is hereby authorized to act on the following items:

The meeting was called to order by Chairman Poindexter followed by the flag salute and roll call.

AGENDA #1 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck to determine that notice of meeting and agenda for this meeting was properly posted in accordance with the Oklahoma Open Meeting Act. AGENDA #5- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve all monthly reports submitted by officers. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. A report was submitted by the Court Clerk.

AGENDA #6- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to open the floor for citizens participation or comments. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. There were none.

AGENDA #7- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to hear report by Human Resources Director Vicki Cossairt. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Cossairt said the county has 133 employes. Since her last report, there have been two hires and two exits. Cossairt said there are actually two positions open for county employment right now, but she keeps others job descriptions posted in case someone qualified comes in and wants to apply.

Cossairt said there have been a few Covid cases in the county and encouraged everyone to exercise precautions such as wiping down handles and washing hands. She said she has a list of precautionary measures available for anyone who wants one.

AGENDA #8- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to hear Solid Waste report from David Morris. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Jay Decker introduced himself and said he was standing in for David Morris who was at the hospital with his wife. Decker said he has worked for Solid Waste for 14 years. He gave a run-down of statistics for calendar year 2023.

In 2023, Solid Waste had 39 full-time and six part-time employees who worked 80,000 hours to run seven days a week. On six of those days, trash was transported to Tulsa. Decker said Solid Waste would transport to Tulsa seven days if the facility was open. As it is, over the weekend, trash must be stored one and a half days at the station.

The 2023 payroll totaled \$672,650.39.

In 2023, Solid Waste collected and received 43,132.7 tons of trash and transported 37,149 tons to the landfill.

Total expenses for Solid Waste for 2023 were \$3,885,603.35, \$341,480.84 of which was for 98,542 gallons of diesel. One-thousand three hundred and eighteen semi-loads of trash were taken to Tulsa.

In 2023, District #1 took 21.22 tons of trash to Solid Waste - which could include anything, even an abandoned house trailer - and 10.57 tons of brush. District #2 took 16.81 tons of trash and 97.52 tons of brush, and District #3 took 4.79 tons of trash and no brush. Decker said since District #3 is a fair distance from the Solid Waste site at Grove, they do not bring as much trash.

Decker said Solid Waste has no on-going lawsuits.

He said the West Siloam Springs city attorney has made the opening of a trash convenience center there difficult. The town of Colcord is ready to go with their convenience center at the waste water system. Decker said the town has the survey and Solid Waste is waiting for the lease. He said buildings are ready to sit on the site.

Forty new dumpsters were purchased with a \$41,000 grant. Solid Waste paid \$2,000 for the matching portion.

Solid Waste went out for bids on three pieces of equipment: a backhoe, roll-off truck and two walk-in enclosed trailers. He provided each commissioner with a copy of the latest audit and told them to call Morris if they have any questions.

Poindexter asked the results of the equipment bids. Decker said the low bidder on the 2022, 115 horsepower Case backhoe was Victor L. Phillips. A total of \$237,390 was spent for both trailers. Purchase of the roll-off truck has not been decided because collection has slowed and the purchase may not be justified.

Decker said Solid Waste would like to thank Commissioner Callihan for his help whenever he is asked.

AGENDA #9- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to open the floor for new business. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. There was none.

AGENDA #10- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve blanket purchase orders for February 2024. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #11- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve highway cash for February 2024. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #12- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to receive and file Administration and Registration Report from the Election Board. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #13- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to pay invoice from Craig County Detention Center for December 2023 in the amount of \$600. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #14- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to surplus 2019 Caterpillar 140 motor grader, D307-0120, Serial #ON9400123, on behalf of District #1. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #15- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve the purchase of a 2023 Caterpillar motor grader from Warren Cat on Sourcewell #032119-CAT at \$363,941 and select financing on behalf of District #1. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Poindexter said the grader is a Model 150 and he will finance half the amount and pay half down. After reading financing offers from Welch State Bank and Bank of Grand Lake, Commissioner Poindexter made a motion to accept the contract with Warren Cat for a motor grader with financing from Bank of Grand Lake. Commissioner Callihan seconded the motion. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. The financed amount will be \$182,241 with payments of \$2,529.20 per month.

AGENDA #16- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action on-call contract with Rose & McCrary. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Callihan said this is his item. He noticed the commissioners pay \$500 per month for this service and he never uses it. He said he knows Commissioner Poindexter has used the service the most. Commissioner Beck said he can never get ahold of Rose and McCrary to use the service. Poindexter asked to be sent the agreement to review the service and put the item on next week's agenda.

AGENDA #17- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action land offer made to school board. Commissioner Poindexter clarified it is the Jay School Board. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Commissioner Callihan said a written officer was made last week for the approximate 30 acres with the intention to build the new fair barn there. At the Jay School Board meeting last Thursday, the board accepted the offer from the county of \$350,000. Callihan said when the contract is drafted, it should include a utility easement. Parker said ADA Marianna McKnight has a contract prepared for the commissioners to review. Callihan said the only stipulation is a jail cannot be built on the property as it is within 1,000 feet of a school.

AGENDA #18- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to adjourn at 9:37 a.m. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.
