

DELAWARE COUNTY COMMISSIONER MEETING MINUTES

January 2, 2024

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on January 2, 2024. The agenda was posted December 28, 2023, at 4:00 P.m. and placed in the kiosk on the courthouse lawn well as the county website. Members of the Board present were Commissioner David Poindexter-Chairman, Commissioner Jake Callihan-Member, Commissioner David Beck-Member, and County Clerk Barbara Barnes. The Board of Delaware County Commissioners is hereby authorized to act on the following items:

The meeting was called to order by Chairman Poindexter followed by the flag salute and roll call.

AGENDA #1 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck to determine that notice of meeting and agenda for this meeting was properly posted in accordance with the Oklahoma Open Meeting Act. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #2-A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve introductions and announcements. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. In addition to the board members and Commissioners' Secretary Kathy Parker, District Attorney Marianna McKnight, Mike Major, Carolyn Boothe, and Sheriff James Beck introduced themselves.

Commissioner Poindexter wished everyone a Happy New Year and delivered the news that long-time Ottawa County District 2 Commissioner Larry McElhaney passed away.

AGENDA #3- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to elect a chairman for the Delaware County Board of Commissioners for 2024. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; Commissioner Beck-yes. Motion carried. Callihan made a motion for Poindexter to remain as chairman. Beck said he thinks the chairman duties should be returned to a rotational basis as they have been in the past. Poindexter said he has served as chairman for five years. Poindexter said since this is an election year for Commissioner Callihan, he will second the motion and the rotation can begin next year. Callihan said he agrees the rotation should be resumed. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; Commissioner Beck-yes. Motion carried.

AGENDA #4- A motion was made by Commissioner Poindexter and seconded by Commissioner Beck to approve the minutes for the regular meeting dated December 27, 2023. Roll call: Commissioner Poindexter-abstain; Commissioner Callihan-yes; Commissioner Beck-yes. Motion carried.

AGENDA #7- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to open the floor for citizens participation or comments. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. There were none.

AGENDA #8- was not needed.

AGENDA #9- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to open the floor for new business. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. There was none.

AGENDA #9- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss funding budgeted accounts for dispatch Personal Services (93A) and dispatch M&O (93D) for the remainder of this fiscal year 23/24. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Poindexter said when the budget was made, no money was put in for dispatchers since it was unclear when dispatcher pay would be moved from the sheriff's payroll to the E-911 Trust Authority. He was it was decided instead to transfer the necessary funds. Poindexter asked Barnes if that was acceptable. She said that would work just fine. Sheriff Beck asked how much would be transferred because he has more people now than the budget he requested. He said there was a spreadsheet budget for dispatch sent to the County Clerk as requested. Sheriff Beck said it was part of his budget sent to Barnes. Poindexter said in future to email any budget requests to him as well.

AGENDA #10- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action appointment or reappointment of two Grand Gateway Board Member positions for 2024. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Both Poindexter and Barnes said they wished to continue their appointments. A motion was made by Callihan and seconded by Beck to reappoint David Poindexter and Barbara Barnes as Grand Gateway board members. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #11- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with action choice of a board member for the Delaware County Health Department. A motion was made by Poindexter and seconded by Beck to retain Callihan as the board member for the health department. A motion was made by Poindexter and seconded by Callihan to retain Commissioner Beck on the Community Sentencing Board. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Motion carried.

Poindexter said he would like to serve. A motion was made by Beck and seconded by Callihan to appoint Commissioner Poindexter as the Workforce Oklahoma Board Member. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #15- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to purchase a 2024 Chevrolet 2500 truck from Joe Cooper Chevrolet at \$45,461 on state contract SW0035 for District #3.
