DELAWARE COUNTY COMMISSIONER'S MEETING MINUTES

January 28, 2025

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on January 28, 2025. The agenda was posted January 27, 2025, at 8:23 a.m. and placed in the kiosk on the courthouse lawn as well as the county website. Members of the Board present were Commissioner David Poindexter-Chairman, Commissioner Jake Callihan-Member, Commissioner David Beck-Member and County Clerk First Deputy Michaele Baker. The Board of Delaware County Commissioners is hereby authorized to act on the following items:

The meeting was called to order by Chairman Poindexter followed by the flag salute and roll call. County Clerk Barbara Barnes was absent.

There have been no employee exits. The county has 132 employees today. Since last week, three hires have been made and two employees terminated. There are five county job positions open. Cossairt said interviews are continuing. She reminded everyone that all applications should go to the county clerk's office and that no prospective employee may be a third degree relative or closer to someone who already works for the county. Cossairt encouraged everyone to check their HSA accounts as the yearly \$1,000 addition has been made. Cossairt said the W2s will be out on time.

Cossairt asked the commissioners if they wanted to post a custodial position to help and train with custodian David McCord as he intends to retire fully or partially in the next few years. Baker said custodian is a bid position. Cossairt said the commissioners may hire an employee to help the custodian, having nothing to do with the bid position. She said she is merely asking if they wish to advertise a position. Poindexter said this matter should be made an agenda item.
