## **DELAWARE COUNTY COMMISSIONER MEETING MINUTES**

## October 10, 2023

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on October 10, 2023. The agenda was posted October 5, 2023, at 4 p.m. and placed in the kiosk on the courthouse lawn well as the county website. Members of the Board present were Commissioner David Poindexter-Chairman, Commissioner Jake Callihan-Member, Commissioner David Beck-Member, and County Clerk Barbara Barnes. The Board of Delaware County Commissioners is hereby authorized to act on the following items:

AGENDA #7 -A motion was made by Commissioners Callihan and seconded by Commissioner Beck to hear report by Human Resources Director Vicki Cossairt. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Cossairt said the county currently has 133 employees. Cossairt said there are 13 full-time jobs posted by the county. A few of these stay posted all the time for the Sheriff's Office. She urged anyone who knows someone looking for a job to point them toward the employment page on the county's website or the message board on the courthouse lawn. Cossairt said October is flu shot and mammogram month. She said the county's new travel policy is in effect and she will be distributing copies to all the elected officials soon. Cossairt said insurance option period ends today.

AGENDA #8- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to open the floor for new business. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. There was none.

AGENDA #9- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to sign affidavits for the Oct. 13 payroll. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #10- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action for BOCC to pay for a motor for Unit #843 per the Sheriff's Requisitioning Officer Genia Yeager. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Sheriff Beck said he has found a motor in Tulsa. He said there is an \$1800 core charge which will be returned to the county. Callihan asked how many miles are on the truck. Beck said approximately 130,000. Poindexter asked the model of the truck. Beck said it is a 2017. "We had no problems with it before," Beck said. "Then one day we were just driving along and lost all the oil. Poindexter asked who will install the motor. Beck said he is not sure yet, but he will pay for the install with sheriff's sales tax funds.

A motion was made by Callihan and seconded by Beck to buy a motor from Midwest Auto Parts in the amount of \$13,175 paid from the Use Tax account for the Sheriff's Office.
