

DELAWARE COUNTY COMMISSIONER'S MEETING MINUTES

October 29, 2024

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on October 29, 2024. The agenda was posted October 24, 2024, at 3:47 p.m. and placed on the courthouse door as well as the county website. Members of the Board present were Commissioner David Poindexter-Chairman, Commissioner Jake Callihan-Member, Commissioner David Beck-Member and County Clerk Barbara Barnes -Secretary. The Board of Delaware County Commissioners is hereby authorized to act on the following items:

The meeting was called to order by Chairman Poindexter followed by the flag salute and roll call. Commissioner Poindexter and Commissioner Beck were present. Commissioner Callihan was absent.

AGENDA #1 - A motion was made by Commissioner Beck and seconded by Commissioner Poindexter to determine that notice of meeting and agenda for this meeting was properly posted in accordance with the Oklahoma Open Meeting Act. In addition to the Commissioners and County Clerk, Jack Wood, Monkey Island Fire Chief Carl Tesreau, Rocky and Connie Carroll, Carolyn Boothe, HR Director Vicki Cossairt, Ray Thomas, and Emergency Management Director Jeff Reeves introduced themselves.

Commissioner Beck said he was thankful to all the fire departments who responded to the fires in District 3 on Tuesday. Fire Departments responded from across Delaware County as well as from Arkansas to fight a 500-acre fire.

AGENDA #6 - A motion was made by Commissioner Beck and seconded by Commissioner Poindexter to approve opening the floor for citizen's participation or comments. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-absent; and Commissioner Beck-yes. Motion carried. Jack Wood asked what property was the subject of item 12. Commissioner Poindexter said to wait until we get to the item.

AGENDA #7- A motion was made by Commissioner Beck and seconded by Commissioner Poindexter to hear Human Resources report by HR Director Vicki Cossiart. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-absent; and Commissioner Beck-yes. Motion carried. Cossairt said the county has 136 employees today with one termination and one offer. She said there are 10 job postings for the county, seven are standing and three positions are actually open. Cossairt reminded everyone that next week is early voting and to allow and encourage employees to vote. She also reminded that it is time for flu, RSV and Covid vaccinations.

AGENDA #8- A motion was made by Commissioner Beck and seconded by Commissioner Poindexter to open the floor for new business. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-absent; and Commissioner Beck-yes. Motion carried. There was none.

AGENDA #9- A motion was made by Commissioner Beck and seconded by Commissioner Poindexter to sign affidavits for October 31, payroll. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-absent; Commissioner Beck-yes. Motion carried.

AGENDA #10- A motion was made by Commissioner Beck and seconded by Commissioner Poindexter to advertise for sealed bids on the 2025 Resale Title Search specifications and offer on behalf of the County Treasurer's Office for title searches on the property that will be going through the 2025 tax resale. AGENDA #16- A motion was made by Commissioner Beck and seconded by Commissioner Poindexter to discuss with possible action extending burn ban from 11 a.m. October 29 to 11 a.m. November 12, 2024. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-absent; and Commissioner Beck-yes. Motion carried. Commissioner Poindexter asked Reeves to speak. Reeves said when the burn ban was enacted a few weeks ago, there was a mistake on his part. To get back on track, the board will need to re-visit the ban every fourteen days. Commissioner Poindexter questioned how the burn ban exactly works. Reeves said that he refers everyone to the state statute as there can be many variables in play, such as prescribed burns. The county has been following the basic burn law. Jack Wood asked for the statute concerning burn bans. Commissioner Poindexter told Wood it is Title 2, Section 1626.b.1. Commissioner Poindexter made a motion to extend the burn ban to November 12, 2024. Commissioner Beck seconded. Motion carried.

AGENDA #17- A motion was made by Commissioner Beck and seconded by Commissioner Poindexter to adjourn at 9:40 a.m. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-absent; and Commissioner Beck-yes. Motion carried.
