

DELAWARE COUNTY COMMISSIONER'S MEETING MINUTES

October 7, 2025

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on October 7, 2025. AGENDA #11- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to receive and file a copy of Certificate of Liability Insurance and current list of Board of Directors and Officers for the Kansas Fire Department as follows: Johnita Stonecipher – Mayor/Trustee; Darrell Pickup and Chandler Gregory – Trustees; Fire Chief – Donny Jorgensen; Asst. AGENDA #13- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to make a decision concerning school windows, doors, and painting. Poindexter read a quote from the company that has just completed the roof and floor on the historic Delaware County School. The price to frame and install new windows and doors and paint all the wood work is \$44,500. Callihan said the new roof and floor had just been completed when someone broke into the building and vandalized it. He said the building must be secured. Callihan made a motion, seconded by Beck, to

accept the quote from Absolute Roofing. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Barnes said this is an emergency. Thomas suggested getting game cameras for the site. Callihan said it is disheartening to try to fix something only to have it torn up.

AGENDA #14- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to accept a bid in the amount of \$40 from Dakota Harris for Berry Hill Area Flint Ridge 4, Block 17, Lot 66, and Walnut Hill Area Flint Ridge 4, Block 16, Lot 131 on behalf of the County Treasurer. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #15- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action approval of the county budget. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Poindexter said the elected officials have been sent copies of the changes made from the previous meeting. Callihan asked if everyone was good with the changes. There were no comments. A motion was made by Poindexter and seconded by Callihan to approve the budget. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #16- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve temporary operational transfer from Resale M&O to General Government in the amount of \$350,000. Poindexter said this is the money needed to operate the county government until the ad valorum taxes start coming in. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #17- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to hear TIF presentation concerning Phase 1 Rose Rock Lakeside development on Monkey Island. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Attorney Kathy O'Connor gave the presentation. She said she has 30 years' experience in economic development and incentive programs. She helps developers and works mostly with cities.

TIF stands for Tax Increment Finance. She said the developers want to establish a new TIF district to finance the development. She said the TIF can extend up to 25 fiscal years. O'Connor said the aim of a TIF is to bring reinvestment to an area, attract investment or increase the tax base. The county would get the original tax for the property and any tax increase from the improvements goes to the developer. At the end of the TIF, the county would begin receiving all of the higher tax rate. Assessor Larena Cook said the current tax on the property is less than \$100 because the land is pasture that is zoned agricultural. O'Connor said the question is if the development would occur the same way as quickly without the TIF.

O'Connor said there are three parts to establishing a TIF. First as per state law, a review committee must be assembled that includes a person from every entity that would be affected by the agreement. Next, a set of project plans must be prepared. The last stage is the project plan is approved, but this is a slow process and two public hearings are required. O'Connor said the developers would like to include some sales tax as well as property tax.

O'Connor said the project is a mixed-use development on 94 acres that would include 358 homes and commercial property. She called it a "fully amenitized" community. Over the next 25 years, she said \$320 million in investment, \$500,000 per year in estimated sales, and over \$82 million in revenue is expected.

Callihan asked if the county can be liable for expenses incurred by the developer. O'Connor said the county would enter a contract with the developer, but if something goes wrong it would be the developer's problem. He asked if the development would happen without a TIF. She said no. Poindexter asked if the TIF is transferrable. O'Connor said the county would need to make a new development contract with the new owner. O'Connor said the commercial construction would be finished by 2027-28, but the residential development would be continuing. She said the county will benefit from jobs created by the development. Chris Hill said all the construction workers will be local. Johnson said Trinity Construction operates from a Claremore office. The development will not have a motel, the commercial area will be all shops and office space. Cook said if the jobs created are mostly service jobs, Shangri La cannot find enough people to fill the jobs it has available now. O'Connor said the hope is this development will bring economic stability creating more year-round business opportunity. She said this development will have an impact outside the TIF district. O'Connor said this meeting is to see if there is any interest. The first step is for the county to hire a lawyer, but the developers said they will pay the fees. No action was taken.

AGENDA #17- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss the county-wide internal controls quarterly check list. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Cossairt said all the items on the first page regarding the handbook are done. Barnes said her office keeps up with audit findings, financial statements and SEFA reports as listed on #6, page 2.

Cossairt said concerning compliance with the law on page 3, #10, there is a new law, (1178) barring pets from the work place. After Nov. 1, only service animals will be allowed in county buildings. She said the signage has already been posted and she has a letter from ACCO saying there would be no insurance for any occurrence that involved an animal inside a county building which is not a service animal. She said the county follows the law stating all CDL drivers must go through the DOT clearing house before they can go to work. She said she is working with the D.A. on the statute that requires all firefighters to be drug tested. Cossairt said even though dispatchers are no longer paid through the county, new law classifies them as public safety officers and this may affect their benefits and retirement. She said the state auditor's office advised her that anything to do with payroll should be signed by the commissioner as a best practice. Even if the designated signatory signs, the commissioner should sign also.

Concerning risk assessment, Cossairt said she and Reeves talk about this with individuals and groups and they also evaluate accidents.

Poindexter said concerning #5 on page #3, all county equipment is properly marked with identification and the insurance schedule is updated each time items are disposed or acquired.

Barnes said her office is on guard for fraud risk which come often in emails. She said parties are advised they must come into the office to make changes or get information when the question is suspect or asks for personal information or to change personal information. Concerning #14 on page 4, Barnes said the Clerk and Treasurer's offices work diligently to make sure the segregation of duties is exercised.

AGENDA #19- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to adjourn the meeting at 10:24 a.m. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.
