

DELAWARE COUNTY COMMISSIONER'S MEETING MINUTES

April 15, 2025

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on April 15, 2025. The agenda was posted April 14, 2025, at 8:47 a.m. and placed in the kiosk on the courthouse lawn as well as the county website. Members of the Board present were Commissioner David Poindexter-Chairman, Commissioner Jake Callihan-Member, Commissioner David Beck-Member and County Clerk Deputy Michaele Baker. The Board of Delaware County Commissioners is hereby authorized to act on the following items:

The meeting was called to order by Chairman Poindexter followed by the flag salute and roll call. County Clerk Barbara Barnes was absent.

AGENDA #5 – A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve all monthly reports submitted by officers. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. A report was submitted by the Court Clerk.

AGENDA #6 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck for approval of citizen's participation or comments. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Rocky Carroll said he wished to give the commissioners a letter written to the governor by state fire departments supporting the Department of Forestry in Oklahoma. He gave a copy of the letter to the BOCC, but there are no signatures on the letter. In addition, none of the fire departments listed on the letter are from Delaware County.

Carroll said he has been traveling in Tennessee and Cannon County has a cemetery mapping system he would like to see used in Delaware County. He said he has been working on a system to map cemeteries in Delaware County for three years. Carroll said he asked Cherokee Nation to identify their cemeteries to expedite the mapping. Carroll would like the BOCC to approve this cemetery mapping plan.

Mike Major said in reference to the items about courthouse cleaning bids, the county has a courthouse maintenance account and he would like the county to use that money to pay for cleaning instead of using other accounts such as Use Tax. In fact, the courthouse maintenance accounts are always used for the cleaner's salary and the cleaning products. Perhaps Major was referring to a one-time purchase recently for a small steam floor cleaner.

AGENDA #7- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to hear a report from Human Resources Director Vicki Cossairt. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Cossairt said the county has 134 employees today. Since last week, one new employee is in process, one exit has been made, and one transfer was made between departments. There are nine county employment position open, two of which are seasonal. Cossairt gave the BOCC a letter from the Health Department confirming the price for tuberculosis tests increased to \$20 on May 1. Cossairt said since many of the elected officials could not be present today, items 9 and 10 about bereavement and inclement weather policies for the county handbook should be tabled until next week's meeting.

AGENDA #12- A motion was made by Commissioner Callihan and seconded by Beck to accept and deposit \$40,000 donation check for paving one mile on South 583 Road in District #2. Callihan said this is in the Zena area. Residents contributed \$40,000 and Cherokee Nation will pay \$45,000 for the job. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #13- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve a donation paving project for three tenths of a mile on Road 639 in Wolfe Half Acres District #1 in the amount of \$20,000. Poindexter said his crew will be paving 640 Road, and the residents wanted to pay to pave the approach from their houses to 640. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #14- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve an estimate from OMNI Watch in the amount of \$2,901.42 to service tornado sirens on behalf of Emergency Management. Reeves said these three sirens are on Monkey Island and were purchased with grant funds. He said there are approximately 28 sirens in the county not counting those in the City of Grove. Reeves said recently Cherokee Nation did a need study which concluded Delaware County needs 45 sirens. He hopes CN will help get more sirens. Reeves said he will continue moving south to get all the sirens serviced a few at a time. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. The commissioners agreed the payment can come from Use Tax.

AGENDA #15- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve an intrafund transfer from General Government Contingency (20C) to General Government Commissioners' Travel (08c) in the amount of \$5,000 per County Commissioner David Poindexter.
