

DELAWARE COUNTY COMMISSIONER MEETING MINUTES

April 23, 2024

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on April 23, 2024. The agenda was posted April 22, 2024, at 8:25 a.m. and placed in the kiosk on the courthouse lawn well as the county website. Members of the Board present were Commissioner David Poindexter-Chairman, Commissioner Jake Callihan-Member, Commissioner David Beck-Member, and County Clerk First Deputy Michaele Baker. The Board of Delaware County Commissioners is hereby authorized to act on the following items:

The meeting was called to order by Chairman Poindexter followed by the flag salute and roll call. County Clerk Barbara Barnes was absent.

AGENDA #1 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck to determine that notice of meeting and agenda for this meeting was properly posted in accordance with the Oklahoma Open Meeting Act. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #2-A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve introductions and announcements. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. AGENDA #5- Not needed because no monthly reports were submitted by officers.

AGENDA #6- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to open the floor for citizens participation or comments. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. There were none.

AGENDA #7- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to hear Human Resources report by Human Resources Director Vicki Cossairt. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Cossairt said the county has 141 full-time employees, two new employees start today, one in the court clerk's office and one on sheriff's patrol, three employees were termed. Cossairt said 16 positions are posted, with five actually open.

AGENDA #8- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to open the floor for new business. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. There was none.

AGENDA #9- A motion was made by Commissioner Callihan and seconded by Commissioner Beck sign affidavits for the April 30 payroll. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #10- A motion was made by Callihan and seconded by Beck to approve blanket purchase orders for May. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #11- A motion was made by Callihan and seconded by Beck to approve highway cash for May. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #12- A motion was made by Callihan and seconded by Beck to hear a report from Attorney David Floyd of Floyd and Driver. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Floyd said he had three topics to cover with the commissioners. First was the American Rescue Plan Act. Floyd said the LECTF report due the end of March has been completed. The account still has funds in it which the commissioners may use however they choose. The annual APRA report is due in May and he is working with Barnes to complete it, Floyd said the deadline has been met to encumber all the ARPA funds. The money must all be spent by Dec. 31, 2026. Two weeks ago, Floyd said the legislature made some provisions for cost over runs or overbids, so those funds, if appropriated, are not lost. Floyd will make sure contingency plans are in place for the county to recover funds if necessary. Floyd said the Justice Authority got bonds in 2012 to pay for the sheriff's office lawsuit. The lawsuit was paid off last year and now the bonds are gone. The IRS sent an IDR letter to the county which is the possibility of an audit. Since the debt is paid and the bonds are gone, the IRS decided there will be no audit. Floyd presented a letter from the IRS stating the matter is closed.

Item three concerned government investment pools. Floyd said HB 2538 was passed allowing entities to put cash together to invest, thereby lowering the risk to any one entity. Floyd said schools have been doing this since the 90s. An interlocal agreement has been approved by the governor. If the BOCC wishes to participate, a resolution must be signed stating the desire to participate.

Poindexter asked how commission is paid. Floyd said an outside company will be hired for management. Fees will be taken off the top of the investment earnings. Floyd said currently returns from these type investments are running about one-half percent better than the bank. Floyd said there are no penalties to remove or add funds to the investment account. The pool can only invest in the same type vehicles as the county may invest on its own: such as government bonds and AAA-rated investments. Floyd said the investment pool will be up and running in 60 to 90 days.

AGENDA #13- A motion was made by Callihan and seconded by Beck to discuss with possible action subdivision plat named Easy Creek on behalf of Tim McCrary. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. This subdivision is in District 1 east of Bernice. Poindexter said the roads are private. Poindexter made a motion, seconded by Callihan to accept and sign the plat. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #14- A motion was made by Callihan and seconded by Beck to accept and sign Cherokee Nation Housing Development plat inside the City of Jay named Ganohili Addition on behalf of the Housing Authority of the Cherokee Nation. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #15- A motion was made by Callihan and seconded by Beck to discuss with possible action change orders on the E-911 remodel. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Poindexter said the purpose of this decision is not to pay change orders, but to approve whether or not the contractor should continue with them. Orders 9 through 12 are included in this request. Number 11 is a small refund for a door not being used. Number nine is a pony wall in the dispatch room to accommodate electrical conduit inside the framing. Number 10 adds a pass-through window. Number 12 is to power wash and seal brick. After some discussion, the commissioners decided to approve all except #12. Some research will be done on the cost of sealant and the power washing can be done with commissioners' equipment and labor.

A motion was made by Callihan and seconded by Beck to approve potential change orders nine, 10 and 11. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #16- A motion was made by Callihan and seconded by Beck to surplus two printers #C-225.49, S#3TX407926 and C-225.50, S#3TX407879 per the Treasurer's Office. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.
