

DELAWARE COUNTY COMMISSIONER'S MEETING MINUTES

June 10, 2025

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on June 10, 2025. AGENDA #6 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck for approval of citizen's participation or comments. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. There were none.

AGENDA #7- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to hear a report from Human Resources Director Vicki Cossairt. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Cossairt said the county has 129 employees today. The county has 24 job openings. She thanked Josh Bynum for designing ads which are running on the internet. Two reserve officers are in process. Cossairt said reserves do not count as employees and volunteer their time for no pay. Cossairt said she has asked for an executive session to be added next week to discuss a candidate for the custodial position. Cossairt reminded elected officials to budget for employee awards and longevity pay. Cossairt said Cassidy Daugherty who works for the sheriff's office had a daughter born last week.

AGENDA #8- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to open the floor for new business. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Callihan said there are still leaks in the courthouse roof and Accurate Roofing has showed up to patch it whenever they were called, but the roof needs to be sealed. He said he provided the specs to Barnes to advertise for bids and hopes the job can be let for bid soon.

Commissioner Poindexter skipped to item #22.

AGENDA #22- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action presentation from sheriff concerning grant for Grand Lake Mental Health which has a June 11 deadline. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Jail Administrator D.J. Goff said the office wants to apply for an opioid grant through the Attorney General's Office. Grand Lake Mental Health already partners with the sheriff's office. This grant is to address opioids coming into the jail, Goff said, and the S.O. needs BOCC support to apply for the grant. Jim Warren of Grand Lake Mental Health said GLMH has done this in several counties and he has been assessing Delaware County, which probably is a candidate for a co-responder. The county's liability is lowered with a co-responder on staff, Warren said. He asked for approval to submit an application for the grant. The amount is based on demographics. The letter of support is needed today as the application deadline is tomorrow. Cossairt said GLMH already provides services for employees concerning drugs and drug addiction. A motion was made by Callihan and seconded by Beck to provide a letter of support from the BOCC written to the A.G. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.
