

## **DELAWARE COUNTY COMMISSIONER'S MEETING MINUTES**

## June 17, 2025

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on June 17, 2025. The agenda was posted June 16, 2025, at 8:22 a.m. and placed in the kiosk on the courthouse lawn as well as the county website. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. The sheriff said the cars up for salvage bid on item #21 are mostly junk. Some are crashed, some do not run and others have parts that may be salvaged. Thomas said the vehicles are at the District #2 County Barn and he hopes someone will write one check and take them all.

AGENDA #7- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to hear a report from Human Resources Director Vicki Cossairt. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Cossairt said the county has 128 employees today. One new hire is in process for a detention officer. No exits have been made since last week. The county has 17 open positions for employment.

Cossairt asked elected officials to focus on wellness. She said one lap around the courthouse square on the sidewalk is one quarter of a mile, so just four trips around would make a mile.

Cossairt said HB1168 passed, which increases the amount of government liability from \$25,000 to \$75,000 and \$125,000 to \$500,000. She said this means the county's liability insurance premiums could increase.

In addition, the trust authority board has discussed hiring a person whose sole responsibility it is the work out any problems.
