

DELAWARE COUNTY COMMISSIONER'S MEETING MINUTES

June 3, 2025

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on June 3, 2025. The agenda was posted June 2, 2025, at 8:25 a.m. and placed in the kiosk on the courthouse lawn as well as the county website. Members of the Board present were Commissioner David Poindexter-Chairman, Commissioner Jake Callihan-Member, Commissioner David Beck-Member and County Clerk Barbara Barnes. The Board of Delaware County Commissioners is hereby authorized to act on the following items:

The meeting was called to order by Chairman Poindexter followed by the flag salute and roll call. All members were present.

Reports were submitted by the County Clerk, Assessor, Health Department, Treasurer, and Election Board.

AGENDA #6 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck for approval of citizen's participation or comments. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Cook said regarding the item to sign and record a plat, the current version of the plat causes more questions than answers. Barnes agreed.

AGENDA #7- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to hear a report from Human Resources Director Vicki Cossairt. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Cossairt said the county has 129 employees today. Since last week, there have been no hires and no exits. The county has 15 jobs open. Cossiart said Judy Sturges, who worked as the Commissioners' Secretary for over 39 years, has died. Her visitation is tomorrow from 6 to 8 p.m. at Lawson's Funeral Home in Jay and funeral services are 11 a.m. Wednesday at the First Assembly of God in Jay.

Cossairt gave some statistics on the "sandwich generation," which is people raising their own children and taking care of their ailing parents at the same time. Cossairt said 48 percent of this generation are caregivers. Twenty-eight percent of the generation have reduced their time working, or had to reduce or give up their retirement benefits. Twenty-one percent have gone back to work and 14 percent have quit work to be caregivers.

Cossairt said the county had a wellness program in the past, and she would like to get that reinstated. She wants to find some space in the courthouse for treadmills as walking is good for the body and spirit. She said the treadmills could possibly be donated.

A report on civility in the work place recently crossed Cossairt's desk. She said \$2 billion has been lost in the United States from this issue. She said she believes in the "power of one."

Cossairt presented a new law which goes into effect Nov. 1 concerning service animals. While the bill is designed to protect trained service animals, it also provides penalties for people who misrepresent an animal or pet as a service animal. Legal service animals who are entitled to go anywhere their owner goes, are only those trained to provide services for those people with disabilities. Cossairt suggested purchasing signs for county buildings declaring them safe zones for service dogs. The law is designed to help Oklahomans who truly need service animals and prevents businesses, including government buildings, from being overrun with people misrepresenting their pets.

AGENDA #9- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to appoint a local elected official as per the consortium agreement workforce innovation and opportunity act for Green Country Workforce Development Area, tabled from the May 27 meeting. Beck was the appointee last time and seemed eager to fill the position again. A motion was made by Poindexter and seconded by Callihan to appoint David Beck to the Workforce Development Consortium. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #10- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to accept John Dunn as Delaware County Fair Board member from District #3. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #16- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to open and review all bids received with possible acceptance for an M350 RTK drone on behalf of the Grove Fire Department. Bid #2024-2025. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Two bids were received: Drone Nerds at \$31,997 and Quadracopter at \$35,139.22. Desilva took the bids to review.

AGENDA #18- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve resolution establishing and designating county depositories for the county treasurer. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Returning to item #16, Desilva returned and said he would like to accept the lowest and best bid from Drone Nerds. A motion was made by Callihan and seconded by Beck/ to accept the bid from Drone Nerds in the amount of \$31,997. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Poindexter asked how long it would take to receive the drone. Desilva said the company has one in stock.

AGENDA #20- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to hear a presentation from Tommy Wylie of Advanced Workzone Services. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Wylie said two companies are trying to steal the traffic cone market offering cheaper prices for substandard cones. To combat the take-over, Advanced is offering a pallet of 225 cones for \$4,725, or \$21 each. There is free freight for shipping to one address. He said Advanced has sign shops in Muskogee, Oklahoma City and Tulsa and they also do striping.

AGENDA #23- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action agreement for services between Nimbus Resilience Solutions LLC and Delaware County, Okla., per request of Jeff Reeves, Emergency Management Director. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Reeves explained this is a consulting company for grant writing. Their fee is five percent of any grant received. If a grant Nimbus worked on is not received, the company gets no pay. Reeves said many of the larger grants require a lot of leg work, such as the one to add 10 storm sirens to the county and this company can help with that. He asked the BOCC to approve using the service which will be no cost to the county. He added that the Washington County District Attorney approved this same contract last week. Both Callihan and Beck wanted the Delaware County D.A, to look at the contract. A motion was made by Callihan and seconded by Beck to approve the contract pending Doug Pewitt's approval. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #24- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve utility permit (road bore) issued for Coxcom, LLC, located at S. 710 Rd., E. 710 Rd., E. 422 Rd. in District #2; S. 670 Rd., E. 500 Rd., E. 530 Rd., 495 Rd. in District #3. Point of contact is Jason Combs. A \$1,000 bond has been collected and deposited.
