

DELAWARE COUNTY COMMISSIONER'S MEETING MINUTES

August 26, 2025

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on August 26, 2025. The agenda was posted August 25, 2025, at 8:40 a.m. and placed in the kiosk on the courthouse lawn as well as the county website. Roll call: Commissioner Poindexter-yes; Commissioner Beck-yes. Motion carried. Cossairt said the county has 134 employees today. Since last week, there have been two new hires and no terminations. Cossairt said six people are in CDL school, which will finish this Saturday. They will be tested the following Saturday. The county has five full-time employment opportunities open. Cossairt said some cases of covid have been reported in Delaware County, so be aware and keep up handwashing and social distancing. She said Labor Day holiday is coming and thanked those who will be working in advance.

AGENDA #9- A motion was made by Commissioner Beck and seconded by Commissioner Poindexter to sign payroll affidavits for the Aug. 29 payroll. Roll call: Commissioner Poindexter-yes; Commissioner Beck-yes. Motion carried.

AGENDA #10- A motion was made by Commissioner Beck and seconded by Commissioner Poindexter to handle the ETR request for District #3 that was tabled from the August 19 meeting with approval to discuss with possible action Emergency Transportation Revolving fund request for District #3 in the amount of \$161,950 to asphalt overlay one mile of \$600 Road from U.S. Highway 412 traveling north to the intersection of E 550 Road. Roll call: Commissioner Poindexter-yes; Commissioner Beck-yes. Motion carried. Beck said this application got confused, so this item is to clear up the second request for paving that was on the last application. A motion was made by Poindexter and seconded by Beck to approve the request for paving on \$600 Road. Roll call: Commissioner Poindexter-yes and Commissioner Beck-yes. Motion carried.

AGENDA #11- A motion was made by Commissioner Beck and seconded by Commissioner Poindexter to approve "See You At The Pole" prayer service on the courthouse lawn Sept. 24 at 6 p.m. Roll call: Commissioner Poindexter-yes; Commissioner Beck-yes. Motion carried.

AGENDA #12- A motion was made by Commissioner Beck and seconded by Commissioner Poindexter to sign an agreement with consultant for Federal Emergency Management Agency and Oklahoma Department of Emergency Management per Emergency Management Director Jeff Reeves. Reeves said this gives him signatory powers for grant applications and the letters that go along with them. He said this will make the process quicker and easier. Reeves stressed that this will only be for grants the BOCC has already approved pursuing. Roll call: Commissioner Poindexter-yes and Commissioner Beck-yes. Motion carried.

AGENDA #13- A motion was made by Commissioner Beck and seconded by Commissioner Poindexter to sign services agreement with Guy Engineering for right of way acquisition on the Beaty Creek Bridge project on behalf of District #2. He said the project will probably be done in September. A motion was made by Poindexter and seconded by Beck to accept the donation for materials for overlay on E247 Road.
