DELAWARE COUNTY COMMISSIONER'S MEETING MINUTES

August 6, 2024

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on August 6, 2024. The agenda was posted August 5, 2024, at 8:35 a.m. and placed on the courthouse door as well as the county website. Members of the Board present were Commissioner David Poindexter-Chairman, Commissioner Jake Callihan-Member, Commissioner David Beck-Member and County Clerk Barbara Barnes - Secretary. The Board of Delaware County Commissioners is hereby authorized to act on the following items:

The meeting was called to order by Chairman Poindexter followed by the flag salute and roll call. All members were present.

AGENDA #1 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck to determine that notice of meeting and agenda for this meeting was properly posted in accordance with the Oklahoma Open Meeting Act. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #2-A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve introductions and announcements. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. AGENDA #5 – A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve all monthly reports submitted by officers. Reports were submitted by the Health Department, Assessor, Sheriff, and Election Board. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #6 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck for approval of citizen's participation or comments. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. There were none.

AGENDA #7- Was not needed as the Human Resources Director was ill.

AGENDA #8-A motion was made by Commissioner Callihan and seconded Commissioner Beck to open the floor for new business. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Poindexter thanked both the other commissioners for helping him with a paving project.

AGENDA #9- A motion was made by Commissioner Poindexter and seconded by Commissioner Callihan to receive and sign funding agreement between the BOCC and Delaware County E-911 Trust Authority for dispatcher pay, tabled from the July 30 meeting. Roll Call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Beck asked for the amount, which was left blank in the contract. The amount was left blank because the budget has not been approved and the lawyers crafting the contract had no way to know the amount. Barnes said the amount allotted for dispatch in the last budget was \$506,000. McKnight said an amount must be filled in before the Commissioners sign. Poindexter suggested using last year's amount as this year's amount will be at least as much. Beck asked if the contract must be signed now. Poindexter said 911 needs to know how much money the authority will be getting. A motion was made by Callihan, seconded by Beck, to insert \$506,000 into the agreement between the BOCC and Delaware County E-911 Trust Authority for dispatcher pay. Roll Call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #10- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve officers for the Delaware County Sheriff's Office as follows: Purchasing Officers – James Beck, Genia Yeager; Receiving Officers – Shannon Anderson, James Morgan: Inventory Officers – Shannon Anderson, James Morgan. Signature designee – James Morgan. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #11- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to advertise for sealed bids for the purchase of a 2024 pickup truck for the Tia Juana Volunteer Fire Department. Persons interested in submitting a bid are to contract Michaele Baker, P.A., located in the County Clerk's Office, Jay, Okla. Bids will be received no later than 8/22/24 at 4 p.m. in the County Clerk's Office, Jay, Okla. Bids will be opened and reviewed in regular meeting dated 8/27/24 at 9 a.m. Board reserves the right to accept/reject any or all bids and the right to re-advertise. Bid# 24-25/01. Ted Terwort said the brush rig the department has carries water and foam, which is too much weight. This truck will have the foam mounted on it and will be four-wheel drive. Beck asked if this is a new truck. Callihan said the bid is for a 2024 model. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #12-A motion was made by Commissioner Callihan and seconded by Commissioner Beck to execute amended 969 Claim Form for loss of revenue to Delaware County and the school districts therein due to the 100 percent DAV exemptions allowed for the year 2023. This will be amending the amount claimed previously on the 969 Claim Form dated February 6, 2024. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried

AGENDA #13- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to hear ACCO Safety Conference update from Commissioner Poindexter. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Poindexter said he attended the conference last week and while safety refreshers are always good, he was interested in the Emergency Management breakout. He said since 2013 there have been 46 major disasters in Oklahoma at a total of \$485 million in damage. Of those disasters, 17 were over \$20 million; 33 counties were affected in those disasters. Poindexter asked Emergency Manager Jeff Reeves if he knows about NOF grants. Poindexter said although there are lots of criteria to apply, it seems the grants might be worth it. Reeves said he has applied for NOF grants. Poindexter said the emphasis was to keep having local safety meetings. Callihan said he would like to get back to safety meetings with Reeves involved.

AGENDA #14- A motion was made by Commissioner Beck and seconded by Commissioner Poindexter to sign offer to purchase real estate adjacent to the E-911 Center and forward it to the real estate agent. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Barnes said she discovered there is an abstract on the property. Callihan suggested a wood privacy fence on two sides with chain link and a rolling gate on the front. Reeves said it is difficult to tell where the property lines are since the land is grown up. Poindexter suggested if the offer is accepted to set a time for anyone interested to go look at the property.
