

DELAWARE COUNTY COMMISSIONER'S MEETING MINUTES

September 16, 2025

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on September 16, 2025. The agenda was posted Sept. 15, 2025, at 8:40 a.m. and placed in the kiosk on the courthouse lawn as well as the county website. Members of the Board present were Commissioner David Poindexter-Chairman, Commissioner Jake Callihan-Member, Commissioner David Beck-Member and County Clerk Barbara Barnes. The Board of Delaware County Commissioners is hereby authorized to act on the following items:

The meeting was called to order by Chairman Poindexter followed by the flag salute and roll call. All members were present.

AGENDA #5 - Was not needed because no monthly reports were submitted by officers.

AGENDA #6 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck for approval of citizen's participation or comments. All comments must pertain to today's agenda items. Speakers should hold their comments to three minutes. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Rocky Carroll said concerning item #12, while he is all for the 412A project, the utility relocation was already done in the past and there was some encroachment by the state. He asked the commissioners to be vigilant.

AGENDA #7- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to hear report by Human Resources Director Vicki Cossairt. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Cossairt said the county has 136 employees today, four new hires are in process, and there were zero terminations since her report last week. The county has seven positions for employment posted; two are seasonal, one is standing and four are open, all in the sheriff's office. She said some flu and covid cases have been detected in Delaware County and this is the time of year for flu shots. She said employees should stay home if they are ill. She encouraged distancing and hand washing.

Cossairt said new legislation from a senate bill could affect the way dispatchers are paid and earn retirement benefits. In the past, dispatchers were classified as administrative clerical employees. Dispatchers will now be classified as protective services employees.

AGENDA #8- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to open the floor for new business. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. There was none.

AGENDA #9- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to sign highway cash for October. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #10- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to sign blanket purchase orders for October. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #11- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible signing plat for Phase I Rose Rock Lakeside on Monkey Island in District 1. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Brooke Fuser said she and her husband bought this property 10 years ago and have spent the last three on this development. She said the plat includes 165 commercial and residential lots. Reeves said the plat is ok as far as the flood plain is concerned. Poindexter said the roads will be private and not maintained by the county. A motion was made by Poindexter, seconded by Callihan to approve and sign the plat. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #12- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to sign 324A forms for Mears Engineers to get reimbursed from ODOT for utility relocation on 412A highway project. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #13- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to sign borrow permit agreement with Scott Craig for materials used for road maintenance and repair in District #2. Callihan said this will be hillside material and gravel. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #14- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to receive and forward to District Attorney tort claim from Stephanie Yeatman against District 3 under the Oklahoma Governmental Tort Claims Act from attorney Greg Denney. Claim was denied by ACCO. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #15- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve resolution to dispose of equipment, Inventory #D356-0001, Caterpillar skid steer, on behalf of District #1. Poindexter said this is a trade in on a newer one just like it to update the inventory. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #16- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to discuss with possible action setting special meeting to discuss the budget with all electeds and others submitting to the budget. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

Callihan said since the budget is getting close to being ready to present, everyone it affects should have a chance to see it. Poindexter said he is meeting with accountant Bill Turner this afternoon to get the final numbers. Callihan suggested having the special meeting after the regular one. A motion was made by Callihan and seconded by Beck to set a special meeting Tuesday, Sept. 23, at 10:30 a.m. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #17- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to adjourn the meeting at 9:31 a.m. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.
