DELAWARE COUNTY COMMISSIONER'S MEETING MINUTES

December 3, 2024

The Board of County Commissioners of Delaware County met in Regular Session at 9:00 a.m. on December 3, 2024. The agenda was posted December 2, 2024, at 8:58 a.m. and placed in the kiosk on the courthouse lawn as well as the county website. Members of the Board present were Commissioner David Poindexter-Chairman, Commissioner Jake Callihan-Member, Commissioner David Beck-Member and County Clerk Barbara Barnes -Secretary. The Board of Delaware County Commissioners is hereby authorized to act on the following items:

The meeting was called to order by Chairman Poindexter followed by the flag salute and roll call. All members were present.

AGENDA #5 – A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve all monthly reports submitted by officers. A report was submitted by the Court Clerk. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Reports were submitted by the Assessor, Health Department and Treasurer.

AGENDA #6 - A motion was made by Commissioner Callihan and seconded by Commissioner Beck for approval of citizen's participation or comments. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Mike Major said regarding item #9, he would like to know why so many vehicles are being surplussed.

AGENDA #7- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to hear report by Human Resources Director Vicki Cossairt. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Cossairt said the county has 127 employees today. Since her last report, one termination has been made. There are three county jobs open. Cossairt reminded everyone it is flu season and time to get shots if you are so inclined. Cossairt thanked all employees that worked on Thanksgiving holiday.

Cossairt presented the short resignation letter from Sheriff James Beck to the commissioners. The letter was two sentences long: To whom it may concern, I am resigning effective immediately as the Delaware County Sheriff. Thank you.

AGENDA #8- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to open the floor for new business. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried. Pewitt said the sheriff's resignation does not constitute a legal emergency. He said appointing an interim sheriff must be done in a special meeting or next Tuesday's agenda. Pewitt said there is "no need to panic," as the sheriff's office can run with no sheriff. Pewitt said the situation warrants two agenda items: to accept the resignation letter and to make an interim appointment for sheriff.

AGENDA #9- No action was taken on this item to surplus vehicles from the Sheriff's Office.

AGENDA #10- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to accept six-month road material bids for the Delaware County Highway Departments. County Bid #24-25/03. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #11- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve an intrafund error transfer from Highway District #1 M&O to Highway District #1 MV in the amount of \$15,169.73 per District #1 Commissioner David Poindexter. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #12- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to approve a temporary transfer from Use Tax to General Fund in the amount of \$250,000 to prevent non-payable warrants until 2024 tax collection begins per Treasurer Treasa Earp. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #13- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to pay annual membership to the National Association of Counties in the amount of \$808. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #14- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to sign contract with Betts Telecom to wire the network system at the E-911 Center. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.

AGENDA #15- A motion was made by Commissioner Callihan and seconded by Commissioner Beck to adjourn at 9:31 a.m. Roll call: Commissioner Poindexter-yes; Commissioner Callihan-yes; and Commissioner Beck-yes. Motion carried.
