AGENDA #5-A motion was made by Commissioner Kirk and seconded by Commissioner Martin to approve to hear Human Resources on current status regarding Families First Coronavirus.

Roll call: Commissioner Poindexter-yes, Commissioner Martin-yes, Commissioner Kirk-yes. Motion carried.

Vicki Cossairt, HR Director, reported that cases continue to increase with 244 diagnosed cases, 175 recovering, 48 active cases and 17 deaths. There has also been a huge spike in Ottawa County. Measures are being taken to keep the courthouse disinfected for COVID prevention. The HR Director and the EM Director are working together to disinfect the courthouse every Friday. Plexiglass is being installed in areas as a safety measure. Cossairt said that if employees are sick, they need to stay home. If an employee becomes sick at work, they need to go home. If an employee has become ill and has been tested for COVID, they need to stay home until test results have been received. The County Clerk's office has changed their schedule to work in the courthouse from 7:30 a.m. to 3:00 Mon – Wed without taking lunches or breaks. The County Clerk's office is working remotely on Thursday. The Treasurer's office and the Court Clerk's office are working from 8:00 a.m. to 3:30 Mon – Thurs. and alternating staffs. The DA's office is working Mon-Fri 8:00 a.m. to 4:30 p.m. with alternating staffs. The Election Board is keeping their regular hours from 9:00

a.m. to 3:00 p.m. Mon-Fri. Courthouse offices are requiring masks in all offices for employees and are practicing social distancing. Documents are being left outside offices in the courthouse as a safety measure to limit contact between office staff members. There is a new website created by Gov. Stitt providing information about the pandemic in Oklahoma. The link is https://coronavirus.health.ok.gov/covid-19-alert-system.
