AGENDA #5- A motion was made by Commissioner Kirk and seconded by Commissioner Martin to approve 308 apportionments for October 2019. Roll call: Commissioner Poindexter-yes, Commissioner Martin-yes, Commissioner Kirk-yes. Motion carried.

AGENDA #6- A motion was made by Commissioner Kirk and seconded by Commissioner Martin to approve sheriff's boarding of prisoner's financial statement for the period ending July 31, 2019. Roll call: Commissioner Poindexter-yes, Commissioner Martin-yes, Commissioner Kirk-yes. Motion carried.

AGENDA #7- A motion was made by Commissioner Kirk and seconded by Commissioner Martin to approve a contract with Mailfinance of Milford, Conn., on behalf of the Treasurer's Office for software and support. Roll call: Commissioner Poindexter-yes, Commissioner Martin-yes, Commissioner Kirk-yes. Motion carried.

AGENDA #8- A motion was made by Commissioner Kirk and seconded by Commissioner Martin to approve a resolution authorizing application for financial assistance from the Rural Economic Action Plan fund on behalf of Delaware County Rural Water District #1. Roll call: Commissioner Poindexter-yes, Commissioner Martin-yes, Commissioner Kirk-yes. Motion carried.

AGENDA #9- A motion was made by Commissioner Kirk and seconded by Commissioner Martin to approve a resolution authorizing an application for financial assistance from the Rural Economic Action Plan fund of behalf of Colcord Schools. Roll call: Commissioner Poindexter-yes, Commissioner Martin-yes, Commissioner Kirk-yes. Motion carried.

AGENDA #10- A motion was made by Commissioner Kirk and seconded by Commissioner Martin to review and discuss a continuing non-compliance request for demonstration of good faith effort to correct non-compliance issues in the jail. This was a revisit for violations previously identified and not corrected. Roll call: Commissioner Poindexter-yes, Commissioner Martin-yes, Commissioner Kirk-yes. Motion carried. Martin said the jail is being run better since a new jail administrator took over.

AGENDA #11- A motion was made by Commissioner Kirk and seconded by Commissioner Martin to approve salvage of a computer monitor and tower on behalf of the Assessor's Office. Roll call: Commissioner Poindexter-yes, Commissioner Martin-yes, Commissioner Kirk-yes. Motion carried.

AGENDA #12- A motion was made by Commissioner Martin and seconded by Commissioner Kirk to receive and forward to ACCO a notice of tort claim filed by Jeremy Wayne Matthews. Barnes said the claim has been emailed to ACCO, the sheriff and assistant district attorney and a paper copy was given to Undersheriff Tracy Shaw. Roll call: Commissioner Poindexter-yes, Commissioner Martin-yes, Commissioner Kirk-yes. Motion carried.

AGENDA #13- A motion was made by Commissioner Kirk and seconded by Commissioner Martin to approve surplus of a 2002 Chevrolet Tahoe on behalf of the Sheriff's Office. Roll call: Commissioner Poindexter-yes, Commissioner Martin-yes, Commissioner Kirk-yes. Motion carried.

AGENDA #14- A motion was made by Commissioner Martin and seconded by Commissioner Kirk to approve a permit for a road bore on Deerlick Road (E. 390 Rd.) and Robin Road intersection for Jerry's Excavation from Hulbert. This is for a water line. Roll call: Commissioner Poindexter-yes, Commissioner Martin-yes, Commissioner Kirk-yes. Motion carried.

AGENDA #15- A motion was made by Commissioner Poindexter and seconded by Commissioner Kirk to approve a resolution authorizing application for financial assistance from the Rural Economic Action Plan fund on behalf of Cleora Fire Department. Fire Chief Bill Ballenger was present to say the grant is for weather warning sirens. Roll call: Commissioner Poindexter-yes, Commissioner Martin-yes, Commissioner Kirk-yes. Motion carried.

AGENDA #16- A motion was made by Commissioner Kirk and seconded by Commissioner Martin to discuss various HR items with HR director Vicki Cossairt with possible action. Roll call: Commissioner Poindexterves, Commissioner Martin-yes, Commissioner Kirk-yes. Motion carried.

Cossairt said she previously told the commissioners the Election Board Secretary would be classified in the Oklahoma Public Employees Retirement System as an elected official after conversations with the district attorney. OPERS has since sent a mandate saying the Election Board Secretary will be classified as a non-elected official (she is appointed) but accrues no vacation or sick time. "I now have written confirmation form OPERS and the auditor she is not classified as an elected official," Cossairt said.

Cossairt discussed Health Savings Account guidelines and asked the commissioners their preference. One plan is for all full time employees who have been employed for a minimum of one full year on January 1, 2020, to be granted \$1,000 deposited into a Health Savings Account (HSA). Employees who have not been employed for a year on Jan. 1, 2020, will have \$1,000 deposited in an HSA on the first payroll following their one-year anniversary date. Giving the new employees \$1,000 HSA before they have worked a full year will help recruit long-term employees, Cossairt said. In the past, the \$1,000 was not given until one year had passed because there was such a large turnover in the sheriff's department. Once the \$1,000 is deposited, it belongs to the employee even if they leave the job, so waiting a year was meant to save the county money. Cossairt said another option is to deposit \$83.33 into each employee's HSA account every month. At the request of Martin, Cossairt provided some statistics on the turnover in the sheriff's department. "There are 51 paid positions in the sheriff's office," Cossairt said. "During the period of time the statistics were gathered, 35 were hired and 36 left. All 51 positions were never full at one time. Sixty-eight percent of the positions had an 80 percent turnover. Ten percent turnover is very good, but most businesses shoot for 30 percent or less. The turnover cost to the county is substantial, in this case about \$700,000. I have talked to nearly all the employees who left and while they would like to make more money, that is not the reason most of them left." She said in the past year, 524 applications for employment have been received and 455 of those were for law enforcement. She said jobs are posted on the county's website and Indeed job search. Martin asked Cossairt how she believed the turnover rate could be diminished. She said better pre-screening of prospective employees, improved interviews and training for leadership would help. Cossairt passed on a letter submitted by Don Youngblood from ACCO concerning the lack of emergency exits on the third floor.

A motion was made by Kirk and seconded by Martin to approve the written guidelines for HSAs on a yearly basis. Roll call: Commissioner Poindexter-yes, Commissioner Martin-yes, Commissioner Kirk-yes. Motion carried. A motion was made by Martin and seconded by Kirk to follow OPERS and auditor guidelines concerning classification of the Election Board Secretary. Roll call: Commissioner Poindexter-yes, Commissioner Martin-yes, Commissioner Kirk-yes. Motion carried.

AGENDA #17- A motion was made by Commissioner Kirk and seconded by Commissioner Martin to open the floor for any new business. Roll call: Commissioner Poindexter-yes, Commissioner Martin-yes, Commissioner Kirk-yes. Motion carried. Poindexter said Robert Real will be present at the next meeting to

discuss the purchase of warning sirens for the town of West Siloam Springs. "They don't have the money and he can get them a grant for 80 percent," Poindexter said.

AGENDA #18-A motion was made by Commissioner Kirk and seconded by Commissioner Martin to open the floor for citizen's participation or public comments. Roll call: Commissioner Poindexter-yes, Commissioner Martin-yes, Commissioner Kirk-yes. Motion carried. Sandy Sullins said she is from Lakeport in the Hickory Grove area and she is protesting herbicide spraying which is killing trees and plants. She said this is not the first time this has happened. "Why are they spraying in residential areas?" Sullins said. "What chemicals are they using and in what concentrations? I watched a truck with a white tank on it spray into the water. We have never had any mowers. Is there a replacement plan for our plants?"

Poindexter asked if she had any pictures. She said she has pictures of the plants but not of the truck. The spray is to control vegetation along the roadway, Poindexter said. "You can file a tort claim with the District 1 office. Please bring me pictures of the damage."

Mike Major asked if there was any work on the county audit done by the state or the independent audits done on county trusts. The answer to both was no. He asked if the crime rate statistics were also gathered in the employment ones Cossairt prepared.

"I was only looking at the cost of turnover," Cossairt said. Major said higher turnover raises the crime statistics.

AGENDA #19-A motion was made by Commissioner and seconded by Commissioner to adjourn the meeting at 10:08 a.m. Roll call: Commissioner Poindexter-yes, Commissioner Martin-yes, Commissioner Kirk-yes. Motion carried.
