AGENDA #3- A motion was made by Commissioner Poindexter and seconded by Commissioner Kirk to approve and file all Monthly Reports submitted by Officers as follows: Election Board office. Roll call: Commissioner Martin-yes, Commissioner Kirk-yes, Commissioner Poindexter-yes. Motion carried.

AGENDA #4- A motion was made by Commissioner Kirk and seconded by Commissioner Poindexter to approve for discussion the Monkey Island Fire Department purchase in the amount of \$768,853.00 for one 2018 78' E-1 Typhoon custom aerial ladder truck through the Sourcewell Purchasing Group with possible action to be taken. Roll call: Commissioner Martin-yes, Commissioner Kirk-yes, Commissioner Poindexter-yes. Motion carried.

Commissioner Martin asked Monkey Island Fire Chief Carl Tesreau to explain the details concerning the purchase of the new fire truck. Chief Tesreau said that his department protected homes in the 3500 to 4000 sq ft range within a 6 ½ square mile tax assessment area valued at \$55,000,000.00. Tesreau said it made sense to purchase a new truck because there are really no suitable trucks available that are ten years old and a twenty year old truck would cost between \$200,000 to \$400,000. Commissioner Martin said that bank representatives were in attendance with their proposals for financing. Commissioner Poindexter suggested that the lenders present their respective financing offers. Matt Boston with Welch State Bank presented

fixed rates only with various terms. Bank of Grove Lake offered a ten year balloon. Grand Savings Bank offered a five-year fixed with two five-year terms to be renewed at current market rates. Tax Exempt Leasing did not have a representative in attendance, but offered an adjustable rate. Commissioner Martin asked Chief Tesreau if the Bank of Grand Lake proposal would be manageable for his department. Tesreau said yes and that hopefully they would be able to pay the loan down substantially next year from funds leftover from a building bond issue. Commissioner Martin said that in terms of what the department could afford, it looks like Bank of Grand Lake is the better option. Matt Boston of Welch State Bank expressed that he wished that his bank had been told that the County wanted to look at adjustable rates or balloon options and his bank could have provided this information as well. He said Welch State Bank would like the process to compare apples to apples. Tesreau said that he did not get around to all the banks. Matt Boston said that his bank did not get a fair shake on this deal, but he did not want to slow down the process for the fire department. He requested that in the future the process could be clearer and fairer to all lending institutions. Assistant District Attorney, Nick Lelecas stated that this has been kind of a non-traditional acquisition for the County. Typically, the fire departments deal more closely with the County. The County got into this deal late in the process. Vendors are to make contact with lenders as part of the whole package offered. Commissioner Martin asked Carl for his game plan if there were not excess funds from the construction project to pay on the fire truck next year. Tesreau stated that he would pull money out of some of the fire department operational accounts. Commissioner Martin asked Tesreau if this is his Plan B and Tesreau indicated that it is. Martin asked the board for their thoughts. Commissioner Kirk said that there were not a lot of options. Commissioner Poindexter made a motion to accept financing with Bank of Grand Lake and was seconded by Commissioner Kirk. All voted yes. Motion carried.

LaDonna Yelverton from Grand River Abstract explained the research process performed by her staff in order to prepare the quitclaim deeds and ensure their accuracy for the county.
